Outcome: All Program: All

Topic: Claims backlog data tables

(FADT Hansard Proof 31 May 2023, p 76)

Senator Ross Cadell asked:

Senator CADELL: This will be taken on notice because I don't expect it to be delivered today. Answer to question on notice 44 in the supplementary budget estimates contained data tables on the progress of the claims backlog until the end of February 2023. Could that exact same data in exactly the same format be updated to include progress from July 2021, the beginning of the year, up to as frequently as you can for the inquiry by the return of answers to questions on notice? Ms Frame: It would be monthly.

Senator CADELL: Up to May 2023 would be great.

Ms Frame: Yes, we can date that.

Answer

The tables below provide progress on the claims backlog for the 2021-2022 and 2022-2023 up to and including May 2023.

From November 2022, Department of Veterans' Affairs (DVA) changed the way it calculated the number of veterans with claims.

The count of veterans with claims in the backlog provided in tables 1A and 1B for the period July 2021 to October 2022 was a count of the number of veterans with one or more claims in the backlog. If a veteran had claims in more than one claim category, they were counted multiple times. For example, if a veteran had an Initial Liability claim and a Permanent Impairment claim in the backlog they would be counted twice.

The total number of individual veterans with claims in the backlog provided for the months November 2022 to May 2023 in table 1B counts each veteran once, regardless of how many claims they have in progress across multiple claim categories. For example, if a veteran had an Initial Liability claim and a Permanent Impairment claim in the backlog they would only be counted once.

In relation to the information in tables 4A, 4B, 5A and 5B, the time taken to allocate a claim for processing and the overall time taken to process a claim has continued to increase over the months as a result of the growing number of new claims lodged. As claims lodgements outstripped DVA's ability to process, claims remained unallocated for longer, although this time taken is now reducing.
