#### **ANSWER**

- 1. The department is continuing to deliver the three streams (Integration, Translation, and Collaboration) of the Modern Manufacturing Initiative (MMI), involving \$867.1 million across 91 individual grant agreements. The department has regular contact with the grantees, through quarterly progress reports and ad-hoc engagement on specific issues as needed. Applicants who were unsuccessful in obtaining grant funding were provided information about alternative grant opportunities and initiatives relevant to their proposals.
- 2. No.
- 3. As a condition of funding, grant recipients are required to report quarterly on the progress of their projects. The department monitors progress of projects against the grant agreement milestones and schedule of activities, drawing on the provided progress reports, phone and email contact, and site visits as required.
- 4. As above.
- 5. The department has a feedback and complaint form (<a href="https://www.industry.gov.au/contact-us/feedback-and-complaints/feedback-and-complaint-form">https://www.industry.gov.au/contact-us/feedback-and-complaint-form</a>) which can be used to provide feedback or make a complaint about the department's programs or services, including the performance of grant recipients. The submitted forms are forwarded to the relevant area for a

response, with the department aiming to resolve issues within 20 business days where possible. If the complaint includes suspected fraud or security breaches, the information is also forwarded to the Fraud and/or Security teams. The department's website also provides details on how to make direct contact with the Fraud and Security teams in the department.

- 6. While the MMI Collaboration Stream grants involve collaborative partnerships, a single grant recipient is required to take responsibility for delivering the entire project outcomes. If a collaborative partner withdrew from a project, the onus would be on the grant recipient to continue meeting the agreed project outcomes.
- 7. Should a collaborative partner withdraw from a project, it is incumbent on the grantee to ensure it continues to meet project objectives and obligations under the grant agreement. This may require the grantee to source an alternative delivery partner.
