Senator the Hon Sarah Henderson: asked the Department of Education on 1 June 2023—

Senator HENDERSON: Thank you for that. I want to move to the issue of negative vetting. We've asked questions at each estimates about the appropriate security clearances in place for ministers' offices. We have received on a number of occasions a response that not all staff have negative vetting 2 security clearance, as is required. Could I have an update on whether all staff in Minister Clare's office and the offices of other assistant ministers-including your office, Assistant Minister Chisholm-have negative vetting 2 security clearance.

Mr Markovic: My understanding is that, as at today's date, not all advisers have an NV2. The clearance process for the NV2 is initiated by the Department of Finance, when people are appointed, as their employer. The department has an interest to make sure that individuals only get access to the information that they need. We do monitor the progress of getting NV2s but, at this stage, not everyone in all the offices has a current NV2, which is the response that I have provided.

Senator HENDERSON: I am concerned about that because the Department of Finance sponsors ministerial security clearances, but the responsibility sits with the minister and the assistant minister. Assistant Minister, can I ask, in the case of your office, how many of your staff do not have negative vetting clearances, please? Senator Chisholm: I'll take that on notice and come back to you.

Senator HENDERSON: You don't know? Senator Chisholm: I've got some new staff who have only started recently, so I'd have to check where that progress is at. Senator HENDERSON: Without naming those staff, are you able to provide us with a list of staff in your office, the start date of each of those staff members and whether they have the appropriate clearance-which obviously is mandatory? I appreciate that, if they're a new staff member, it takes some time to get the negative vetting clearances in place. Could I also ask that this information is provided in relation to Minister Clare?

Negative Vetting clearances for Ministers' office staff

Answer

As at 15 August 2023, five staff in Minister Clare's office, nine staff in Minister Aly's office and one staff member in Assistant Minister Chisholm's office are at various stages of the security assessment process which is undertaken by the Australian Government Security Vetting Agency.

The department does not hold information about ministerial staff start dates.
