**AE21-346 - Alternative places of detention (APODs) in Australia since 2018**

Senator Nick McKim asked:

Please provide a breakdown on the total number of alternative places of detention (APODs) in Australia at all times since 2018 (prior to the passing of the Medevac Bill), including a breakdown of:

- a. number of total which are hotels/motels;
- b. number of total in each State and territory; and
- c. for each hotel/motel APOD:
  - i. maximum authorised capacity;
  - ii. highest number of people detained there at any time since 2018 (and when that was);
  - iii. number of people per room;
  - iv. amenities available including for freedom of movement, recreation, etc.

*Answer:*

From 1 January 2018 to 31 January 2021, there were 170 Alternative Places of Detention (APODs) used in Australia at any time. APODs are places of immigration detention as defined in the *Migration Act 1958*, approved in writing by the Minister of the Minister's delegate under subparagraph (b)(v) of the definition of "immigration detention" in subsection 5(1) of the Act. Examples of APODs include hotels, motels, apartments, hospitals and aged care facilities.

***a. number of total which are hotels/motels***

As at 31 January 2021, 56 APODs were classified as hotel-type APODs. (The classification of APODs as hotel-type APODs is based on information contained within Departmental systems.)
