**Answer:**

2. Airservices routinely employs experienced air traffic controllers, and periodically undertakes recruitment campaigns domestically (which includes New Zealand) for experienced controllers. To be eligible for employment or reemployment, experienced controllers must meet minimum entry standards. Following a recent recruitment campaign for experienced controllers, Airservices is progressing applications from a number of previous employees, along with other experienced controllers who previously worked for the Royal Australian Air Force (RAAF) or Airways New Zealand.
