**Answer:**

As noted in Civil Aviation Safety Authority's (CASA) response to Committee Question Number 149 (SQ23-003393) from the 2022-23 Supplementary Budget Estimates hearing, CASA's medical records system does not capture information on these specific conditions or diseases in a way that enables the data to be accurately reported without manual review of clinical notes for many thousands of assessments.

Providing the information requested would require a review and collation of free-text information from tens of thousands of records and would be an unreasonable diversion of resources.
