**Answer:**

The Civil Aviation Safety Authority (CASA) receives funding from Department of Foreign Affairs and Trade (DFAT) aid programs to provide technical advice and assistance in the Asia-Pacific. The Pacific Designated Aviation Medical Examiner (DAME) training referred to in CASA's 2022-2023 Annual Report (p.104) took place from 29 April to 7 May 2023 in Fiji.

CASA arranged support through two DFAT mechanisms:

- a Grant Agreement between CASA and DFAT under the Pacific Aviation Support Program; and
- the Transport Sector Support Program (TSSP), a bilateral program between Australia and Papua New Guinea.

The cost of the training to DFAT was approximately \$138,620. This covered registration, travel and accommodation, comprising:

- AUD 49,857.08 cost recovery to CASA under the Grant Agreement;
- AUD 58,293.42 cost recovery to CASA under TSSP; and
- PGK 73,314.50 under TSSP for travel arrangements booked locally in PNG.

Under DFAT programs, CASA provides its administrative and technical support in-kind. CASA does not recover staffing costs and met these costs through business-as-usual arrangements, comprising:

- staff support from the Legal, International and Regulatory Affairs Division to manage DFAT funding, monitoring and evaluation;

- staff support from the Stakeholder Engagement Division to arrange and deliver the training in consultation with the International Air Transport Association (IATA) and Australasian Society of Aerospace Medicine (ASAM); and
- staff salaries for the time above, plus salary allowances for professional development which one staff member chose to use to fund their participation in the DAME training.
