- 2. In 2023, there were 28 complaints which included allegations of Bullying & Harassment (including sexual harassment).
- 3. Five are under formal investigation and awaiting findings.

- 4. 15 matters did not warrant investigation and instead, alternative resolutions were applied such as Training/coaching, Facilitated Conversations, Local Management Action, Counselling, Team Cultural intervention and Support. The remaining 8 matters remain under preliminary assessment.
- 5. Airservices provides quarterly progress reports on its Corporate Plan to the Department of Infrastructure, Transport, Regional Development, Communications and the Arts and Minister of Infrastructure, Transport, Regional Development and Local Government, the Hon Catherine King MP on its Culture program including actions in response to the Broderick & Co progress review.
