Answers:

- 1. The Department of Infrastructure, Transport, Regional Development, Communications and the Arts assesses a draft MDP against requirements outlined in the *Airports Act* 1996 and provides advice to support the minister in making a decision.
- 2. The department administers an Airport Building Control Online (ABCO) system.
- 3. Yes.
- 4. The department has oversight through quarterly reporting by the ABCs and the ABCO system.
- 5. Yes.
- 6. All construction and building works must be notified to the Airport Building Controllers and details of all building and works such as applications including any cost assurance data is provided on the ABCO. Works must also be consistent with the Airport Master Plan.
- 7. Airport Lessee Companies are able to develop the airport site under the Airport Head Leases consistent with Airport Master Plans.
