#### **Answer:**

The Australian Broadcasting Corporation (ABC) is represented by Seyfarth Shaw in the Fair Work Commission and Federal Court legal proceedings commenced by Ms Lattouf. The legal representatives assisting on this matter are a Partner and 2 Associates.

The ABC has engaged 2 barristers for the proceedings.

Disclosure of information about the amount of legal costs in ongoing litigated matters can prejudice the ABC's position in those legal proceedings. The ABC respectfully submits that to avoid prejudice to the ABC's position, or unintended interference or influence of the proceedings, questions on the costs of litigation should be deferred until the conclusion of those proceedings. Concerns over the release of costs information have been raised previously by the ABC in connection with questions about other legal proceedings (while the proceedings remained on foot) however if it is of assistance, the ABC can provide a public interest immunity claim.
