- (4) that it is a devastating disease that is difficult to diagnose early and treat at an advanced stage. A woman dies every 10 hours largely because of the lack of early detection tests and poor knowledge of the disease throughout the community;
- (5) that a recent Senate Community Affairs inquiry into gynaecological cancer in Australia (tabled 27 February 2007) identified a need for increased awareness amongst the broader community about gynaecological cancers and symptoms and better educational support for general practitioners;
- (6) that a survey commissioned by the National Breast Cancer Centre has revealed that half of all Australian women believe incorrectly that a pap smear will detect ovarian cancer and that 56% of women are unable to correctly name any signs or symptoms of the disease; and
- (7) the need for greater focus on education and additional research funding to help Australian scientists to find early detection markers and more effective treatments of this insidious disease. *(Notice given 18 February 2008. Notice will be removed from the Notice Paper unless called on on any of the next 8 sitting Fridays after 22 February 2008.)*

8 **MS HALL:** To move—That the House:

- (1) notes this is the 93rd anniversary of the Gallipoli campaign and in doing so remembers our most famous ANZAC, Private John Simpson Kirkpatrick;
- (2) recognises the extraordinary deeds of John Simpson Kirkpatrick who demonstrated courage above and beyond the call of duty when he and his donkeys rescued injured soldiers from the battle fields in Gallipoli;
- (3) calls for the Government to award a posthumous Victoria Cross to ‘Simpson’ in accordance with the wishes of his World War I Commanding Officers and the many thousands of Australians both young and old who demand this recognition for his acts of bravery;
- (4) believes it is a travesty of justice that he has been denied the award of the Victoria Cross for all these years; and
- (5) notes that all Australians would strongly support the posthumous awarding of his honour. (*Notice given 19 February 2008. Notice will be removed from the Notice Paper unless called on on any of the next 8 sitting Fridays after 22 February 2008.*)

 - (e) the importance of North Australia in the Battle for Australia; and
- (2) commends the Rudd Labor Government in fulfilling an election promise in working to establish an annual day for all Australians to commemorate the Battle for Australia.  - (c) urge the United Nations to act against Iran’s threats to eliminate the State of Israel;
- (3) affirms the principle that no country should be allowed to call for the elimination of another; and
- (4) condemns the incidents to genocide by President Ahmadinejad and other Iranian leaders. (*Notice given 19 February 2008. Notice will be removed from the Notice Paper unless called on on any of the next 8 sitting Fridays after 22 February 2008.*)
