- (1) that the Workplace Relations WorkChoices Bill has had damaging impacts on the livelihoods of working families across Western Sydney;
- (2) that Australian Workplace Agreements are unfairly biased against young people seeking employment as it forces them to negotiate with employees without adequate representation; and
- (3) that the Fairness Test flooded small businesses with red tape while still not providing an adequate safety net for employees, placing unnecessary pressure on local communities across Australia. *(Notice given 18 February 2008. Notice will be removed from the Notice Paper unless called on on any of the next 5 sitting Mondays after 26 May 2008.)*

4 **MR PRICE:** To move—That the House:

- (1) recognises:
  - (a) that the Government has given the Australian Competition and Consumer Commission (ACCC) formal monitoring powers under the *Trade Practices Act* on unleaded petrol, across the petrol supply chain;
  - (b) the importance of ongoing monitoring of the fuel industry with the appointment of a Petrol Commissioner within the ACCC; and
  - (c) that the Petrol Commissioner will also be informally monitoring the price of Liquefied Petroleum Gas (LPG) and diesel; and
- (2) supports further efforts to increase transparency and competition in the fuel industry. *(Notice given 18 February 2008. Notice will be removed from the Notice Paper unless called on on any of the next 5 sitting Mondays after 26 May 2008.)*

5 **MR HARTSUYKER:** To move—That the House condemns the Federal Labor Government for its decision not to proceed with the planned expansions of existing Centrelink call centres in Coffs Harbour, Launceston, and Hobart. *(Notice given 18 February 2008 Notice will be removed from the Notice Paper unless called on on any of the next 5 sitting Mondays after 26 May 2008.)*

6 **MS LIVERMORE:** To move—That the House:

- (1) acknowledges those Australians who have selflessly donated their organs, and those who have given consent to do so, so that others may have the gift of life;
- (2) recognises, in this Organ Donor Awareness Week, the importance of organ donation;
- (3) recognises that although 90% of Australians support organ donation, and while Australia has one of the most successful organ transplantation rates in the world, actual organ donation rates are amongst the lowest in the developed world; and
- (4) supports the Government's initiatives to improve organ donation rates. *(Notice given 18 February 2008. Notice will be removed from the Notice Paper unless called on on any of the next 5 sitting Mondays after 26 May 2008.)*

7 **MS OWENS:** To move—That the House notes:

- (1) that Ovarian Cancer Awareness Week will be held from 24 February to 2 March 2008;
- (2) that ovarian cancer is the sixth most common cause of cancer death in women, with nearly 1,200 Australian diagnoses each year and nearly 800 Australian deaths from it each year;
- (3) that when ovarian cancer is diagnosed at an early stage, the outlook is very good—as many as 90% of women diagnosed early are cured. However, 75% of women are diagnosed at the advanced stage when it is very difficult to treat;
- (4) that it is a devastating disease that is difficult to diagnose early and treat at an advanced stage. A woman dies every 10 hours largely because of the lack of early detection tests and poor knowledge of the disease throughout the community;
- (5) that a recent Senate Community Affairs inquiry into gynaecological cancer in Australia (tabled 27 February 2007) identified a need for increased awareness amongst the broader community about gynaecological cancers and symptoms and better educational support for general practitioners;
- (6) that a survey commissioned by the National Breast Cancer Centre has revealed that half of all Australian women believe incorrectly that a pap smear will detect ovarian cancer and that 56% of women are unable to correctly name any signs or symptoms of the disease; and

- (7) the need for greater focus on education and additional research funding to help Australian scientists to find early detection markers and more effective treatments of this insidious disease. (*Notice given 18 February 2008. Notice will be removed from the Notice Paper unless called on on any of the next 5 sitting Mondays after 26 May 2008.*)
- 8 **MS HALL:** To move—That the House:
- (1) notes this is the 93rd anniversary of the Gallipoli campaign and in doing so remembers our most famous ANZAC, Private John Simpson Kirkpatrick;
  - (2) recognises the extraordinary deeds of John Simpson Kirkpatrick who demonstrated courage above and beyond the call of duty when he and his donkeys rescued injured soldiers from the battle fields in Gallipoli;
  - (3) calls for the Government to award a posthumous Victoria Cross to ‘Simpson’ in accordance with the wishes of his World War I Commanding Officers and the many thousands of Australians both young and old who demand this recognition for his acts of bravery;
  - (4) believes it is a travesty of justice that he has been denied the award of the Victoria Cross for all these years; and
  - (5) notes that all Australians would strongly support the posthumous awarding of his honour. (*Notice given 19 February 2008. Notice will be removed from the Notice Paper unless called on on any of the next 5 sitting Mondays after 26 May 2008.*)
- 9 **MR HALE:** To move—That the House:
- (1) notes:
    - (a) the 66th commemoration (19 February 2008) of the bombing of Darwin;
    - (b) the heroism of defence personnel and the people of Darwin during the raids;
    - (c) the tragic loss of life and injuries suffered in Darwin on 19 February 1942;
    - (d) the national significance of this day in the history of Australia; and
    - (e) the importance of North Australia in the Battle for Australia; and
  - (2) commends the Rudd Labor Government in fulfilling an election promise in working to establish an annual day for all Australians to commemorate the Battle for Australia. (*Notice given 19 February 2008. Notice will be removed from the Notice Paper unless called on on any of the next 5 sitting Mondays after 26 May 2008.*)
- 10 **MR DANBY:** To move—That the House:
- (1) notes statements by President Mahmoud Ahmadinejad of Iran:
    - (a) calling for the destruction of Israel;
    - (b) warning any Muslim who supports Israel that they will burn in the hell of Islam; and
    - (c) denying Nazi genocide against the Jews of Europe and demonising Jews;
  - (2) calls on the Australian Government, Australia being a party to the Convention on the Prevention and Punishment of the Crime of Genocide, to:
    - (a) refer the incitements to genocide by President Ahmadinejad and other Iranian leaders to the appropriate agencies of the United Nations for account;
    - (b) initiate in the International Court of Justice an inter-state complaint against Iran for its criminal violation of the Genocide Convention; and
    - (c) urge the United Nations to act against Iran’s threats to eliminate the State of Israel;
  - (3) affirms the principle that no country should be allowed to call for the elimination of another; and
  - (4) condemns the incidents to genocide by President Ahmadinejad and other Iranian leaders. (*Notice given 19 February 2008. Notice will be removed from the Notice Paper unless called on on any of the next 5 sitting Mondays after 26 May 2008.*)
- 11 **MR PERRETT:** To move—That the House:
- (1) recognises the contributions of multicultural Australia to our social, economic and cultural strength;
  - (2) pays tribute to members of our migrant communities, many of whom have overcome severe hardship and personal tragedy in their homelands before migrating to Australia;
  - (3) commits to uphold the Australian ideal of the ‘fair go’ and strives to build racial harmony in our community;
  - (4) condemns recent political efforts to malign refugee and humanitarian entrant communities; and

- (5) recognises the positive contribution being made by our African–Australian community. (*Notice given 19 February 2008. Notice will be removed from the Notice Paper unless called on on any of the next 5 sitting Mondays after 26 May 2008.*)

**12 MR SIDEBOTTOM:** To move—That the House:

- (1) recognises the heroic efforts of Ordinary Seaman Teddy Sheean and his crew mates upon the sinking of the HMAS *Armidale* on 1 December 1942 off the Timor coast;
- (2) implores the Government to award a posthumous Victoria Cross of Australia to Ordinary Seaman Teddy Sheean to recognise properly his valour and sacrifice on 1 December 1942; and
- (3) urges the Government to establish a mechanism to address outstanding issues and anomalies in the military honours system such as recognising the courageous deeds of people such as Ordinary Seaman Teddy Sheean on 1 December 1942. (*Notice given 19 February 2008. Notice will be removed from the Notice Paper unless called on on any of the next 5 sitting Mondays after 26 May 2008.*)

**13 MR SCOTT:** To move—That the House:

- (1) calls on the Federal Government to commit to ban by the year 2012 the inclusion of all plastic and glass bottles in landfill;
- (2) notes the ban would be supported by implementation of a national program providing a cash refund for all plastic and glass bottles;
- (3) calls on the Federal Government to reimburse grocery and convenience stores that provide collection sites for the empty bottles and provide cash refunds for each bottle, with larger bottles attracting a larger cash refund; and
- (4) calls on the Federal Government to cooperate with local government bodies to ensure that smaller towns in rural, regional and remote Australia receive financial support to establish a collection centre and to transport bottles to the nearest recycling centre. (*Notice given 11 March 2008. Notice will be removed from the Notice Paper unless called on on any of the next 7 sitting Mondays after 26 May 2008.*)

**14 MRS IRWIN:** To move—That the House:

- (1) notes that the abuse of illicit substances is deeply implicated in Australia's most intractable and costly social problems. These extend well beyond direct health and crime costs to issues like child protection, school drop out, suicide, mental illness, homelessness and poverty;
- (2) notes that the full cost of illicit substance abuse to the Australian economy has not been accurately assessed;
- (3) notes that the cost effectiveness of strategies devised to deal with abuse of illicit substances has not been accurately assessed in Australia;
- (4) notes that the efficacy of supply reduction strategies as compared to the efficacy of other measures in reducing the harms of illicit drug abuse has not been accurately assessed in Australia; and
- (5) calls on the Government to initiate an inquiry by the Productivity Commission into the cost of illicit drug abuse in Australia and the cost effectiveness of strategies to address illicit drug abuse and that in accordance with the *Productivity Commission Act 1998*, the Commission may also make recommendations in the report on any matters relevant to the matter referred. (*Notice given 11 March 2008. Notice will be removed from the Notice Paper unless called on on any of the next 7 sitting Mondays after 26 May 2008.*)

**15 MR RAGUSE:** To move—That the House:

- (1) notes that the seat of Forde now experiences an acute shortage of both publicly and privately provided housing and that a large number of constituents are also experiencing mortgage stress; and
- (2) considers Forde and neighbouring electorates of the south-east corner of Queensland as areas that would benefit from the Federal Government's investment in affordable housing.   - (c) that the United Kingdom has entered into social security agreements that include pension indexation with many other nations, including the United States, Israel and Switzerland;
- (3) calls on the Commonwealth Government to commence negotiations for a new social security agreement with the United Kingdom that includes provisions for the indexation of British pensions. *(Notice given 12 March 2008. Notice will be removed from the Notice Paper unless called on on any of the next 7 sitting Mondays after 26 May 2008.)*

**17 MR GIBBONS:** To move—That the House:

- (1) notes the need for Australian businesses to be globally competitive in order to sustain economic prosperity after the current resources boom;
- (2) notes the alarming decline in Australia's productivity and export performance over the last five years;
- (3) notes research findings that less than one in five Australian businesses is currently "world class";
- (4) notes the Government's election commitments and subsequent policy announcements about measures to improve national productivity including public investment in education, skills training and national infrastructure;
- (5) notes research findings that people management practices are the predominant factor affecting company productivity and performance;
- (6) notes research findings that indicate Australian managers are paying insufficient attention to workplace practices and employee satisfaction; and

  - (a) identify workplace factors that positively impact on workplace innovation, excellence and productivity including human resource management practices and organisational culture;
  - (b) develop policies that promote workplace innovation, excellence and productivity including best practice models, codes of practice, awareness programs, business exchanges and awards; and
  - (c) support research, management education and training in conjunction with higher education providers and professional associations. *(Notice given 12 March 2008. Notice will be removed from the Notice Paper unless called on on any of the next 7 sitting Mondays after 26 May 2008.)*

    - (b) that the Ukrainian Famine was one of the greatest losses of human life in one country in the 20th century; and
    - (c) that it remains insufficiently known and acknowledged by the world community and the United Nations as an act of genocide against the Ukrainian nation and its people, but has been recognised as such by the Verkhovna Rada (Parliament of Ukraine);
  - (4) honours the memory of those who lost their lives;
  - (5) joins the Ukrainian people throughout the world, and particularly in Australia, in commemorating these tragic events; and
  - (6) submits that the Australian Government support a resolution to the General Assembly of the United Nations, which may be submitted by the Government of Ukraine, that the Holodomor in Ukraine in 1932-33 be recognised as an act of genocide against the Ukrainian nation and its people. (*Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 6 sitting Mondays after 26 May 2008.*)
