



## 2. Standing order 207 be amended to read:

## 207. Presenting a petition

A petition may be presented in one of two ways:

- (a) The Chair of the Standing Committee on Petitions shall present petitions and/or reports of that committee, and the Chair and one other Member of the Committee may make statements concerning petitions and/or such reports presented, in accordance with standing order 34 (order of business). The time provided may extend for no more than 10 minutes.
- (b) A Member may present a petition during:
  - (i) the period of Members' statements in the Main Committee, in accordance with standing order 192A and standing order 193;
  - (ii) adjournment debate in the House in accordance with standing order 31, and in the Main Committee in accordance with standing order 191; and
  - (iii) grievance debate in accordance with standing order 192B.

### 3. Standing order 209 be amended to read:

#### 209. Petition may be referred to a Minister for response

- (a) After a petition is presented to the House, the Standing Committee on Petitions may refer a copy of the petition to the Minister responsible for the administration of the matter raised in the petition.
- (b) The Minister shall be expected to respond to a referred petition within 90 days of presentation by lodging a written response with the Committee.
- (c) The Chair of the Petitions Committee shall announce any ministerial responses to petitions. After the announcement, ministerial responses shall be printed in Hansard and published on the House's internet website



The meeting times of the Main Committee are fixed by the Deputy Speaker and are subject to change. Adjournment debates can occur on days other than Thursdays by agreement between the Whips.

#### 193. Members' three minute constituency statements

If the Main Committee meets on a Tuesday, Wednesday or Thursday, the first item of business shall be constituency statements by Members. The Deputy Speaker may call a Member to make a constituency statement for no longer than three minutes. The period for Members' constituency statements may continue for 30 minutes, irrespective of suspensions for divisions in the House.

- 16 MR GEORGANAS: To move—That the House:
  - (1) acknowledges the important contributions of Australian, New Zealand, British and Greek soldiers and Greek civilians in the defence of Crete against the 20 May 1941 German invasion;
  - (2) calls for the annual commemoration of the Battle for Crete within Australia as an event of national significance; and
  - (3) encourages reflection on the shared experiences of Australian and Greek nationals through the Battle for Crete, the bond forged between our two nations in a time of war, and the evolution of Australian-Greek relations within the post-war period. (*Notice given 27 May 2008. Notice will be removed from the Notice Paper unless called on on any of the next 5 sitting Mondays after 1 September 2008.*)
- 17 MR JOHNSON: To move—That the House:
  - (1) recognises the strategic importance of India to 21<sup>st</sup> century global geo-politics; and
  - (2) encourages the Australian Government to reverse its short-sighted decision to cancel Australia's uranium sales to India. (*Notice given 27 May 2008. Notice will be removed from the Notice Paper unless called on on any of the next 5 sitting Mondays after 1 September 2008.*)
- 18 MR RANDALL: To move—That the House:
  - (1) recognises the severe financial distress and hardship faced by a number of current and former franchisees throughout Australia as a direct result of franchisor conduct;

- (b) the statement by Australian church leaders issued in a statement of 4 June 2008—prepared by Archbishop Phillip Aspinall, Primate of the Anglican Church of Australia; Rev Gregor Henderson, President of the Uniting Church in Australia; and Archbishop Philip Wilson, President of the Australian Catholic Bishops Conference; and supported by 12 national Heads of Churches, 36 other Australian Church Leaders, 8 Heads of Church and related International Aid agencies—calling for the Australian Government to give a much higher priority to working for peace in the Holy Land; and
- (2) supports the Church Leaders' call on the Australian Government to increase its support for peacemaking between Israel and Palestine, including:
  - (a) persistent advocacy for a freely and peacefully negotiated solution acceptable to both Israelis and Palestinians, whether in the form of two states or one;
  - (b) greater recognition of the plight of Palestinians after 41 years of military occupation;
  - (c) advocacy for the implementation of international law in reaching a negotiated solution;
  - (d) a quadrupling of Australia's aid contribution to the social and economic development of Palestine; and
  - (e) the facilitation of a multi-faith delegation from Australia to visit Israel and Palestine. (*Notice given 4 June 2008. Notice will be removed from the Notice Paper unless called on on any of the next 6 sitting Mondays after 1 September 2008.*)
- 20 **DR JENSEN:** To move—That the House encourages the Government to lift the amount that a person in receipt of an Age Pension can earn from productive employment to an amount equivalent to the senior Australian's tax offset before applying a penalty that reduces their Age Pension payment. (*Notice given 4 June 2008. Notice will be removed from the Notice Paper unless called on on any of the next 6 sitting Mondays after 1 September 2008.*)
- 21 MR SLIPPER: To move—That the House:
  - (1) notes:
    - (a) the continuing human rights concerns in Tibet; and
    - (b) the continuing restrictions on entry to Tibetan areas for journalists, international observers, non-government agencies and foreign diplomats;

  - (6) acknowledges there is bi-partisan support in the Australian Parliament for a peaceful resolution on the differences between Tibet and China; and
  - (7) requests the Government actively to support and monitor progress of the China-Tibet dialogue and to offer its support to help bring about a positive outcome. (*Notice given 5 June 2008. Notice will be removed from the Notice Paper unless called on on any of the next 7 sitting Mondays after 1 September 2008.*)
- 22 MR PYNE: To move—That the House:
  - (1) notes:
    - (a) today there are hundreds of thousands of children working on cocoa farms in Ivory Coast and Ghana and that these children routinely carry heavy loads, and work with fire, chemicals and knives, with little or no protection. Many of them have no chance of going to school;
    - (b) about 70% of the cocoa beans used to make chocolate around the world come from West Africa, namely Ivory Coast and Ghana; and
    - (c) the principal reason that child labour is employed to grow cocoa is because cocoa farmers are paid so poorly for their produce;
  - (2) commends World Vision Australia for its 'Don't Trade Lives' campaign to draw attention to the plight of child exploitation in the world today; and

- (3) calls on the Prime Minister to take action to ensure that the chocolate industry knows Australia is serious about ending child exploitation and slavery by introducing a policy requiring vending machines in Australian Government offices to stock Fair Trade Chocolate exclusively. (*Notice given 5 June 2008. Notice will be removed from the Notice Paper unless called on on any of the next 7 sitting Mondays after 1 September 2008.*)
- 23 MR TUCKEY: To move—That the House recognises the energy, water and agricultural potential of the far north of Australia, and in particular the Kimberley region, and urges the Parliament to give priority to the development of northern Australia. (*Notice given 5 June 2008. Notice will be removed from the Notice Paper unless called on on any of the next 7 sitting Mondays after 1 September 2008.*)
- 24 MR CIOBO: To move—That the House:
  - (1) condemns the Government for abandoning the tourism industry in a time of need;
  - (2) notes the negative impact that the Government's decision to reduce funding for Tourism Australia by \$5.9 million in real terms will have on the tourism industry;

  - (1) is made aware that Juvenile Idiopathic Arthritis (JIA) affects as many as 1 in 250 Australian children, and that its associated eye disease is the leading cause of childhood blindness in Australia today;
  - (2) recognises the physical, emotional, and financial burden that this chronic disease places upon the family unit; and
  - (3) calls on the Government to:
    - (a) establish a National Database for JIA, so that early diagnosis and professional support can be given to these families through the Australian Paediatric Rheumatology Group; and
    - (b) implement specialised clinics with Visiting Medical Officers at major regional hospitals throughout Australia. (*Notice given 16 June 2008. Notice will be removed from the Notice Paper unless called on on any of the next 7 sitting Mondays after 1 September 2008.*)
- 26 MR BROADBENT: To move—That the House:
  - notes the recent decision of the Federal Court to award costs against the incorporated community group, Your Water Your Say, following an unsuccessful action against the Australian and Victorian Governments in relation to the proposed construction of a Water Desalination plant at Wonthaggi, in the Electorate of McMillan;

    - (a) waive the court costs awarded to the Commonwealth as a result of the failed court action by Your Water Your Say; and
    - (b) agree not to pursue individual members of Your Water Your Say for the recovery of the costs. (*Notice given 16 June 2008. Notice will be removed from the Notice Paper unless called on on any of the next 7 sitting Mondays after 1 September 2008.*)
- 27 MR SCOTT: To move—That the House:
  - (1) calls on the Federal Government to amend finance legislation so as to prevent credit providers from sending unsolicited letters offering an increased credit limit to credit card holders; and
  - (2) notes the amended legislation would stipulate that for a credit card limit to be increased, the card holder must make the first approach to the credit provider. (*Notice given 17 June 2008. Notice*

will be removed from the Notice Paper unless called on on any of the next 7 sitting Mondays after 1 September 2008.)

- 28 MS REA: To move—That the House requests that the Australian Government:
  - (1) condemn the illegal continued detention of Daw Aung San Suu Kyi and demand the immediate release of Daw Aung San Suu Kyi and the 18 members of parliament who are in prison, along with other political prisoners;

    - (c) the Burmese military dictatorship has refused to acknowledge the results of the 1990 election, in which the National League for Democracy of which Daw Aung San Suu Kyi was General Secretary, won an overwhelming majority; and
    - (d) Daw Aung San Suu Kyi has refused a number of opportunities to leave Burma, even to visit her dying husband, knowing that she would be denied the right to return to continue the struggle for democracy and human rights in Burma;
  - (2) welcomes the Australian Government's continued advocacy on behalf of democracy in Burma;
  - (3) calls on the Government to continue to pressure the Burmese regime to immediately and unconditionally release Daw Aung San Suu Kyi and all political prisoners in Burma including a number of Members of Parliament and to commence an inclusive national reconciliation process to restore genuine democracy in Burma; and
  - (4) that the House congratulates Daw Aung San Suu Kyi on her birthday and for her efforts to campaign for human rights and democracy on behalf of the people of Burma. (*Notice given 19 June 2008.* Notice will be removed from the Notice Paper unless called on on any of the next 8 sitting Mondays after 1 September 2008.)
- 30 MS VAMVAKINOU: To move—That the House:
  - (1) recognises the social, economic and human cost of the current Palestinian-Israeli conflict;
  - (2) notes the broader implications of the Palestinian-Israeli conflict in terms of regional stability as well as diplomatic relations in the Middle East;
  - (3) condemns all forms of violence as an obstacle to peace;
  - (4) supports the renewal of diplomatic efforts to negotiate a just and lasting peace and recognises the efforts of the Quartet-led Road Map to peace in the Middle East;

  - (8) believes that Australia has an important role to play as a middle power in encouraging peace initiatives between Palestinians and Israelis that are consistent with Australia's commitment to multilateral diplomacy, responsible international citizenship and the principles of international law.   - (1) supports the provision of the highest quality health services to Australians;
  - (2) notes the continuing advances in medical science, making available new diagnostic tools; and
  - (3) recognises the need to extend the availability of Positron Emission Tomography (PET) scanning to regional Australia. (Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 2 sitting Mondays after 1 September 2008.)
- 3 **INTEREST RATES:** Resumption of debate (*from 22 February*) on the motion of Mr Bradbury—That the House:
  - (1) notes:
    - (a) the recent increases in interest rates;
    - (b) the impact that rising interest rates are having on families, particularly in western Sydney; and
    - (c) the Reserve Bank of Australia's warnings in its latest Statement on Monetary Policy of the risks to the Australian economy of continued inflation; and
  - (2) supports the Government's five-point plan to fight inflation. (Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 2 sitting Mondays after 1 September 2008.)
- 4 **MINISTERIAL ACCOUNTABILITY:** Resumption of debate (*from 22 February 2008—Mr Hayes, in continuation*) on the motion of Mr Johnson—That the House:
  - (1) acknowledges its support for the advancement of democracy around the world, including Pakistan; and
  - (2) recognises the importance of ministerial accountability in our Westminster system of government. (Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 2 sitting Mondays after 1 September 2008.)
- 5 **75TH ANNIVERSARY OF THE UKRAINIAN FAMINE:** Resumption of debate (*from 22 February 2008— Mrs Hull, in continuation*) on the motion of Mr Danby—That the House:
  - notes that 2007 marks the 75th anniversary of the Great Ukrainian Famine—Holodomor—of 1932-33, caused by the deliberate actions of Stalin's communist Government of the Union of Soviet Socialist Republics;
  - (2) recalls that an estimated 7 million Ukrainians starved to death as a result of Stalinist policies in 1932-33 alone, and that millions more lost their lives in the purge that ensued for the remainder of the decade;
  - (3) notes:
    - (a) that this constitutes one of the most heinous acts of genocide in history;
    - (b) that the Ukrainian Famine was one of the greatest losses of human life in one country in the 20th century; and

- (c) that it remains insufficiently known and acknowledged by the world community and the United Nations as an act of genocide against the Ukranian nation and its people, but has been recognised as such by the Verkhovna Rada (Parliament of Ukraine);
- (4) honours the memory of those who lost their lives;
- (5) joins the Ukrainian people throughout the world, and particularly in Australia, in commemorating these tragic events; and
- (6) submits that the Australian Government support a resolution to the General Assembly of the United Nations, which may be submitted by the Government of Ukraine, that the Holodomor in Ukraine in 1932–33 be recognised as an act of genocide against the Ukrainian nation and its people. (Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 2 sitting Mondays after 1 September 2008.)
- 6 **INDEPENDENT REVIEWER OF TERRORISM LAWS BILL 2008** (*Mr Georgiou*): Second reading (*from* 17 March 2008). (Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 4 sitting Mondays after 1 September 2008.)
- 7 HOUSING: Resumption of debate (from 17 March 2008) on the motion of Mr Clare—That the House:
  - (1) notes:
    - (a) the pain being felt by Australian families struggling to pay off mortgages due to rising interest rates;
    - (b) the failure of the previous government to heed the warnings of the Reserve Bank; and
    - (c) the need for low cost home ownership and reduced entry costs for home buyers as well as a range of rental options for moderate to low income households;
  - (2) supports the Government's commitment to tackling this problem by appointing a Minister for Housing and by making it a key priority for COAG in 2008; and
  - (3) welcomes the Government's plan to help first homebuyers break into the housing market with the first-home saver account scheme. (*Order of the day will be removed from the Notice Paper unless reaccorded priority on any of the next 4 sitting Mondays after 1 September 2008.*)
- 8 NORTHERN TERRITORY INTERVENTION: Resumption of debate (*from 17 March 2008—Mr Truss, in continuation*) on the motion of Mr Abbott—That the House:
  - (1) calls on the Government to end the permit system preventing access to remote Northern Territory townships;
  - (2) calls on the Government to restore the pornography bans put in place by the former Government; and
  - (3) urges the Government to not further water-down the Northern Territory intervention. (Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 4 sitting Mondays after 1 September 2008.)
- 9 **TRAVESTON CROSSING DAM:** Resumption of debate (*from 26 May 2008—Mr Dreyfus, in continuation*) on the motion of Mr Truss—That the House:
  - (1) notes that:
    - (a) the Queensland Government will soon deliver an environmental impact assessment of its proposed Traveston Crossing Dam to the Federal Minister for the Environment, Heritage and the Arts, the Hon Peter Garrett MP, under the *Environment Protection and Biodiversity Conservation Act 1999*;
    - (b) the Traveston Crossing Dam is an expensive, inefficient, unreliable and environmentally destructive option for delivering water to Brisbane;
    - (c) the Traveston Crossing Dam will displace hundreds of Mary Valley families, inundate some of the finest farm land in south east Queensland, and destroy at least \$1 billion of infrastructure;
    - (d) the Traveston Crossing Dam will decimate the habitat and threaten the survival of the rare or endangered Mary River turtle, the Australian lung fish, the Mary River cod and a range of other species; and
    - (e) the Traveston Crossing Dam will significantly reduce water flows into the Great Sandy Straits Ramsar listed wetlands, threatening fish breeding, Dugong feeding areas and the waters of Hervey Bay and World Heritage listed Fraser Island; and
  - (2) calls on the Minister for the Environment, Heritage and the Arts, the Hon Peter Garrett MP to exercise his powers under the *Environment Protection and Biodiversity Conservation Act 1999* to

reject the Traveston Crossing Dam absolutely. (Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 5 sitting Mondays after 1 September 2008.)

- 10 **BUDGET:** Resumption of debate (*from 26 May 2008—Mr Hartsuyker, in continuation*) on the motion of Mr Turnour—That the House congratulates the Government on bringing down a budget that:
  - (1) begins tackling Australia's 16 year high inflation rate and puts downward pressure on interest rates so as to ease the pressure on family budgets;
  - (2) delivers on the Government's election commitments restoring confidence in an electorate cynical about political promises; and
  - (3) sets out a plan to tackle the long term challenges facing the nation so as to secure our prosperity into the future. (Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 5 sitting Mondays after 1 September 2008.)

- 12 **GENETICALLY MODIFIED CROPS:** Resumption of debate (*from 2 June 2008*) on the motion of Mr Broadbent—That the House:
  - (1) urges the Australian Government to act to restrict any further planting of genetically modified crops in Australia, the use of genetically modified products in the manufacture of food in Australia and the sale in Australia of food products containing genetically modified material until a full, independent, scientific investigation is carried out to determine:
    - (a) the level of risk to health of foodstuffs containing genetically modified organisms; and
    - (b) the threat of contamination posed by genetically modified crops already planted under relaxed provisions in Queensland, New South Wales and Victoria to crops and the food chain as it relates to livestock production in general on neighbouring properties; and
  - (2) calls on the Australian Government, in considering its course of action, to take into consideration the commitments made by the current Prime Minister on this issue in the lead up to the 2007 Federal Election. (Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 6 sitting Mondays after 1 September 2008.)
- 13 **ZIMBABWE:** Resumption of debate (*from 16 June 2008—Mr Robb, in continuation*) on the motion of Ms Parke—That the House:
  - (1) notes the grave and ongoing humanitarian and political crisis in Zimbabwe;
  - (2) expresses its concern at the unacceptable delay in the release of official results from the 29 March 2008 presidential election in that country, and records its concern that this delay was part of a ploy by the incumbent Mugabe Government to fraudulently retain power;
  - (3) asserts that the democratic choice of the people of Zimbabwe must be respected, and that the second, run-off presidential election, to be held by 31 July 2008, must be free, fair and without intimidation;
  - (4) calls on the Zimbabwe Election Commission to invite international election observers to monitor the election including observers from the African Union and the United Nations;
  - (5) confirms its commitment to the fundamental democratic requirement of a free and open media, and urges the Zimbabwe Government to allow international media full access to Zimbabwe to report on and properly scrutinise the run-off election;
  - (6) condemns the use of violence and other kinds of intimidation or manipulation by election participants in Zimbabwe, including by associates of the ruling Zimbabwe African National Union – Patriotic Front party, in attempts to pervert the democratic process;
  - (7) expresses its hope that the election process can be resolved in order that a properly constituted government of Zimbabwe can turn its full attention to addressing the serious problems afflicting its people, including severe food shortages, a spiralling rate of HIV/AIDS infection, high level unemployment, raging inflation and the lack of basic health services;
  - (8) welcomes the Australian Government's humanitarian aid to Zimbabwe which provides humanitarian relief and human rights support for ordinary Zimbabweans; and
  - (9) supports the Minister for Foreign Affairs in his efforts on Australia's behalf in seeking to cooperate with the United Nations, other nations, and relevant non-government organisations to bring a rapid and peaceful resolution to the political impasse in Zimbabwe, and to address the humanitarian crisis in that country. (*Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 7 sitting Mondays after 1 September 2008.*)

- \*14 SAVE OUR SOLAR (SOLAR REBATE PROTECTION) BILL 2008 (Mr Hunt): Second reading (from 23 June 2008). (Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 8 sitting Mondays after 1 September 2008.)
- \*15 CLEANERS: Resumption of debate (*from 23 June 2008—Ms Ley, in continuation*) on the motion of Mr Georganas—That the House:
  - (1) acknowledges the important contributions of cleaners across Australia as recognised through the International Day for Cleaners in June 2008;
  - (2) recognises that cleaners require jobs that provide them with basic economic security, enough time to do their jobs properly, and respect in their workplaces as essential elements of these reforms;
  - (3) supports the call for a fair go for cleaners across Australia; and

(*Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 7 sitting Mondays after 1 September 2008*.)

## PRIVATE MEMBERS' BUSINESS

#### Orders of the day

- 1 EPILEPSY: Resumption of debate (from 17 March 2008) on the motion of Ms Hall—That the House:
  - (1) recognises that epilepsy is the most common serious brain disorder and is the most universal of all medical disorders;
  - (2) acknowledges that 200,000 people live with epilepsy at any one time in Australia and that up to three times as many Australians will have epilepsy at some time in their lives;
  - (3) that people living with epilepsy are disadvantaged by lack of research into the disorder and by the lack of a national plan for epilepsy or deeming it a disorder that is a national priority;
  - (4) acknowledges the impact that epilepsy has on the lives of people living with it;
  - (5) calls on the Australian Government to fund greater research into epilepsy; and
  - (6) calls on the Australian Government to establish a nationwide educational strategy on epilepsy modelled on the World Health Organisation's global campaign. (*Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 4 sitting Mondays after 1 September 2008.*)
- 2 DARFUR: Resumption of debate (*from 17 March 2008*) on the motion of Mr Broadbent—That the House consider what action should be taken by the Australian Government in response to the humanitarian tragedy that is Darfur. (*Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 4 sitting Mondays after 1 September 2008.*)
- 3 **DISABILITY SUPPORT AND CARE:** Resumption of debate (*from 17 March 2008*) on the motion of Mrs Gash—That the House:
  - (1) calls on the Australian Parliament to adopt a bipartisan approach to improving the provision and delivery of disability support and care to Australians living with severe and permanent disability, their families and/or their carers;
  - (2) considers that for too long the ball of responsibility for the funding and delivery of disability support and care has been kicked between Federal and State governments and that game has to end; and
  - (3) considers that the Federal Parliament must address the need for improved disability funding, support and services to see progress is continued beyond the individual terms of governments and is coordinated at such a level that inter-governmental disability service provision is clear, concise and indisputable. (Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 4 sitting Mondays after 1 September 2008.)
- 4 **WORKPLACE FACTORS:** Resumption of debate (*from 26 May 2008*) on the motion of Mr Gibbons— That the House:
  - (1) notes the need for Australian businesses to be globally competitive in order to sustain economic prosperity after the current resources boom;
  - (2) notes the alarming decline in Australia's productivity and export performance over the last five years;
  - (3) notes research findings that less than one in five Australian businesses is currently "world class";
  - (4) notes the Government's election commitments and subsequent policy announcements about measures to improve national productivity including public investment in education, skills training and national infrastructure;
  - (5) notes research findings that people management practices are the predominant factor affecting company productivity and performance;
  - (6) notes research findings that indicate Australian managers are paying insufficient attention to workplace practices and employee satisfaction; and
  - (7) supports the establishment of a National Commission for Workplace Innovation and Excellence that will, in conjunction with the business community, trade union movement, professional associations and education providers:
    - (a) identify workplace factors that positively impact on workplace innovation, excellence and productivity including human resource management practices and organisational culture;
    - (b) develop policies that promote workplace innovation, excellence and productivity including best practice models, codes of practice, awareness programs, business exchanges and awards; and

- (c) support research, management education and training in conjunction with higher education providers and professional associations. (*Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 5 sitting Mondays after 1 September 2008.*)
- 5 MICROFINANCE: Resumption of debate (*from 26 May 2008*) on the motion of Mr Wood—That the House:
  - (1) notes that:
    - (a) microfinance has proven to be a particularly effective and sustainable means of eradicating poverty;
    - (b) microfinance borrowers, particularly women, generate income that allows them to feed, clothe, educate and care for the health of their children;
    - (c) in December 2006, 93 million of the poorest people had access to microfinance services, which is a 12-fold increase since 1997;
    - (d) in support of the poverty eradication goal of the Millennium Development Goals, the Microcredit Summit Campaign, launched in 1997, is working to expand microfinance to 175 million of the poorest people by 2015;
    - (e) the Microcredit Summit Campaign is holding an Asia-Pacific Microcredit Summit in Bali between the 29<sup>th</sup> and 30<sup>th</sup> July 2008;
    - (f) the Asia-Pacific region contains 64% of the world's population who live in absolute poverty, and as such it has a large unmet need for credit and other financial services; and
    - (g) the Bali Summit is a significant opportunity to examine ways to expand the use and effectiveness of microfinance in the region and to realise the Government's policy objective of reducing poverty in the Asia-Pacific region; and
  - (2) urges the Australian Government to send the appropriate Minister and appropriate Shadow Minister as leaders of an Australian delegation to the Asia-Pacific Microcredit Summit in Bali in July 2008. (Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 5 sitting Mondays after 1 September 2008.)
- 6 **OVARIAN CANCER:** Resumption of debate (*from 26 May 2008*) on the motion of Ms Owens—That the House:
  - (1) that Ovarian Cancer Awareness Week will be held from 24 February to 2 March 2008;
  - (2) that ovarian cancer is the sixth most common cause of cancer death in women, with nearly 1,200 Australian diagnoses each year and nearly 800 Australian deaths from it each year;
  - (3) that when ovarian cancer is diagnosed at an early stage, the outlook is very good—as many as 90% of women diagnosed early are cured. However, 75% of women are diagnosed at the advanced stage when it is very difficult to treat;
  - (4) that it is a devastating disease that is difficult to diagnose early and treat at an advanced stage. A woman dies every 10 hours largely because of the lack of early detection tests and poor knowledge of the disease throughout the community;
  - (5) that a recent Senate Community Affair's inquiry into gynaecological cancer in Australia (tabled 27 February 2007) identified a need for increased awareness amongst the broader community about gynaecological cancers and symptoms and better educational support for general practitioners;
  - (6) that a survey commissioned by the National Breast Cancer Centre has revealed that half of all Australian women believe incorrectly that a pap smear will detect ovarian cancer and that 56% of women are unable to correctly name any signs or symptoms of the disease; and
  - (7) the need for greater focus on education and additional research funding to help Australian scientists to find early detection markers and more effective treatments of this insidious disease. (*Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 5 sitting Mondays after 1 September 2008.*)
- 7 **BLOOD DONATION:** Resumption of debate (*from 2 June 2008*) on the motion of Mr Hayes—That the House:
  - (1) recognises and celebrates the significant contribution which Australia's voluntary donors make to the Australian community as we approach World Blood Donor Day in June 2008;
  - (2) recognises that whilst one in three people will at some stage require blood, presently only one in thirty people actually donate blood;

- (3) supports the efforts of the selfless individuals who give their blood to help save the lives and improve the health of people whom they may never meet;
- (4) congratulates the Australian Red Cross Blood Service for drawing attention to the need for more Australians to donate blood and celebrating the many generous and voluntary, unpaid blood donors who give blood each week to help those in need;
- (5) supports the efforts of the Minister for Health and Ageing and the Parliamentary Secretary to the Minister for Health and Ageing to increase the rate of blood donations in Australia; and
- (6) encourages members to actively encourage blood donation in their electorates. (*Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 6 sitting Mondays after 1 September 2008.*)
- 8 **BOTANY BAY AND THE KURNELL PENINSULA:** Resumption of debate (*from 2 June 2008*) on the motion of Mr Morrison—That the House:
  - (1) recognises that:
    - (a) the Kurnell Peninsula of southern Sydney is the traditional land of the Gweagal people of the Dharawal nation;
    - (b) the landing site of Lieutenant James Cook on April 29, 1770 at Kurnell is the modern birthplace of our nation and is recognised on the National Heritage List;
    - (c) the village of Kurnell is a strong local community comprising approximately 700 homes;
    - (d) Botany Bay is a valuable marine environment providing sanctuary for migratory birdlife and habitat for territorial marine creatures; and
    - (e) construction of the desalination pipeline has commenced across Botany Bay from the Kurnell Peninsula, under approval as critical infrastructure by the New South Wales State Government;
  - (2) expresses concern that:
    - (a) Part 3A of the *Environmental Planning and Assessment Act 1979* in New South Wales exempts critical infrastructure projects from all planning instruments and codes that might otherwise apply, precludes third party rights of appeal and limits powers and penalties in relation to enforcement of breaches of conditions;
    - (b) due to the use of Part 3A of the Act, the impacts of the construction of this pipeline on the marine environment and cultural heritage of Botany Bay and the Kurnell Peninsula are unknown; and
    - (c) since construction has commenced, there have been a series of breaches in relation to the failure of silt nets to contain land fill on Silver Beach at Kurnell; sheet pilling testing has exceeded nominated noise vibration benchmarks, posing a threat to resident property; and there is concern in the community about the ongoing impacts and failures of this project; and
  - (3) calls on the Minister for the Environment, Heritage and the Arts to protect the physical environment and cultural heritage of Botany Bay and the Kurnell Peninsula by requesting the New South Wales State Government to:
    - (a) prepare a comprehensive environmental remediation plan to address the impact of developing the desalination plant, including the pipeline across Botany Bay;
    - (b) conduct such environmental studies as are required to determine the impact of the development of the desalination plant and associated pipeline on the environment, and to make such studies available to the public;
    - (c) ensure that the development of environmental remediation plans is a requirement for any future referred approvals for critical infrastructure projects to the Commonwealth by the New South Wales Government that are subject to Part 3A of the *Environmental Planning and Assessment Act 1979*;
    - (d) prepare a heritage and community remediation plan that addresses the impact and disruption caused to residents and the area by the construction of the desalination plant and associated pipeline; and
    - (e) ensure the New South Wales State Government and its agents monitor and report on the ongoing impacts of the project and commit to informing residents in advance of any issues that may impact on residents or their local environment. (*Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 6 sitting Mondays after 1 September 2008.*)

- 9 **PLASTIC AND GLASS BOTTLES:** Resumption of debate (*from 2 June 2008*) on the motion of Mr Scott— That the House:
  - (1) calls on the Federal Government to commit to ban by the year 2012 the inclusion of all plastic and glass bottles in landfill;
  - (2) notes the ban would be supported by implementation of a national program providing a cash refund for all plastic and glass bottles;
  - (3) calls on the Federal Government to reimburse grocery and convenience stores that provide collection sites for the empty bottles and provide cash refunds for each bottle, with larger bottles attracting a larger cash refund; and
  - (4) calls on the Federal Government to cooperate with local government bodies to ensure that smaller towns in rural, regional and remote Australia receive financial support to establish a collection centre and to transport bottles to the nearest recycling centre. (*Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 6 sitting Mondays after 1 September 2008.*)
- 10 **MENTAL HEALTH SERVICES:** Resumption of debate (*from 16 June 2008*) on the motion of Mr Pyne— That the House:
  - (1) recognises the importance of providing state-of-the-art mental health care for the mentally ill;
  - (2) acknowledges that the way to help the mentally ill rehabilitate from their illness is to improve mental health services, not cut them; and
  - (3) notes that mental health services in South Australia are under threat from the State Government with the proposed sale and redevelopment of the Glenside Campus. (Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 7 sitting Mondays after 1 September 2008.)
- 11 AUTISM: Resumption of debate (from 16 June 2008) on the motion of Mr Hayes—That the House:
  - (1) affirms its recognition that a combination of special education, speech therapy, occupational therapy and behavioural interventions has proved to be successful in helping people with an autism disorder;
  - (2) recognises early diagnosis and intervention is also essential to ensure families and carers have access to appropriate services and professional support;
  - (3) supports the Federal Government policy to establish specialised child care and early intervention services for children with autism; and
