- (2) welcomes the Australian Government's continued advocacy on behalf of democracy in Burma;
- (3) calls on the Government to continue to pressure the Burmese regime to immediately and unconditionally release Daw Aung San Suu Kyi and all political prisoners in Burma including a number of Members of Parliament and to commence an inclusive national reconciliation process to restore genuine democracy in Burma; and
- (4) that the House congratulates Daw Aung San Suu Kyi on her birthday and for her efforts to campaign for human rights and democracy on behalf of the people of Burma. (*Notice given 19 June 2008. Notice will be removed from the Notice Paper unless called on on any of the next 8 sitting Mondays after 1 September 2008.*)

30 **MS VAMVAKINO:** To move—That the House:

- (1) recognises the social, economic and human cost of the current Palestinian-Israeli conflict;

  - (4) congratulates the organisers of Australian Organ Donor Awareness Week across the country for drawing attention to the need for more Australians to become registered organ donors and to discuss their choice with their families;
  - (5) notes that the report of the National Clinical Taskforce on Organ and Tissue Donation sets out a number of directions for improvement in Australian policies and practices; and
  - (6) encourages Members actively to encourage organ donation in their electorates. (*Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 2 sitting Mondays after 1 September 2008.*)
- 2 **HEALTH SERVICES:** Resumption of debate (*from 22 February 2008*) on the motion of Mr Lindsay—That the House:
  - (1) supports the provision of the highest quality health services to Australians;
  - (2) notes the continuing advances in medical science, making available new diagnostic tools; and
  - (3) recognises the need to extend the availability of Positron Emission Tomography (PET) scanning to regional Australia. (*Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 2 sitting Mondays after 1 September 2008.*)

  - (b) that the Ukrainian Famine was one of the greatest losses of human life in one country in the 20th century; and
  - (c) that it remains insufficiently known and acknowledged by the world community and the United Nations as an act of genocide against the Ukrainian nation and its people, but has been recognised as such by the Verkhovna Rada (Parliament of Ukraine);
- (4) honours the memory of those who lost their lives;
- (5) joins the Ukrainian people throughout the world, and particularly in Australia, in commemorating these tragic events; and
- (6) submits that the Australian Government support a resolution to the General Assembly of the United Nations, which may be submitted by the Government of Ukraine, that the Holodomor in Ukraine in 1932–33 be recognised as an act of genocide against the Ukrainian nation and its people. (*Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 2 sitting Mondays after 1 September 2008.*)
- 6 **INDEPENDENT REVIEWER OF TERRORISM LAWS BILL 2008** (*Mr Georgiou*): Second reading (*from 17 March 2008*). (*Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 4 sitting Mondays after 1 September 2008.*)
- 7 **HOUSING**: Resumption of debate (*from 17 March 2008*) on the motion of Mr Clare—That the House:
- (1) notes:
- (a) the pain being felt by Australian families struggling to pay off mortgages due to rising interest rates;
  - (b) the failure of the previous government to heed the warnings of the Reserve Bank; and
  - (c) the need for low cost home ownership and reduced entry costs for home buyers as well as a range of rental options for moderate to low income households;
- (2) supports the Government's commitment to tackling this problem by appointing a Minister for Housing and by making it a key priority for COAG in 2008; and
- (3) welcomes the Government's plan to help first homebuyers break into the housing market with the first-home saver account scheme. (*Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 4 sitting Mondays after 1 September 2008.*)
- 8 **NORTHERN TERRITORY INTERVENTION**: Resumption of debate (*from 17 March 2008—Mr Truss, in continuation*) on the motion of Mr Abbott—That the House:
- (1) calls on the Government to end the permit system preventing access to remote Northern Territory townships;
  - (2) calls on the Government to restore the pornography bans put in place by the former Government; and
  - (3) urges the Government to not further water-down the Northern Territory intervention. (*Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 4 sitting Mondays after 1 September 2008.*)
- 9 **TRAVESTON CROSSING DAM**: Resumption of debate (*from 26 May 2008—Mr Dreyfus, in continuation*) on the motion of Mr Truss—That the House:

- (2) calls on the Minister for the Environment, Heritage and the Arts, the Hon Peter Garrett MP to exercise his powers under the *Environment Protection and Biodiversity Conservation Act 1999* to reject the Traveston Crossing Dam absolutely. - (6) condemns the use of violence and other kinds of intimidation or manipulation by election participants in Zimbabwe, including by associates of the ruling Zimbabwe African National Union – Patriotic Front party, in attempts to pervert the democratic process;
- (7) expresses its hope that the election process can be resolved in order that a properly constituted government of Zimbabwe can turn its full attention to addressing the serious problems afflicting its people, including severe food shortages, a spiralling rate of HIV/AIDS infection, high level unemployment, raging inflation and the lack of basic health services;
- (8) welcomes the Australian Government’s humanitarian aid to Zimbabwe which provides humanitarian relief and human rights support for ordinary Zimbabweans; and

- (9) supports the Minister for Foreign Affairs in his efforts on Australia's behalf in seeking to cooperate with the United Nations, other nations, and relevant non-government organisations to bring a rapid and peaceful resolution to the political impasse in Zimbabwe, and to address the humanitarian crisis in that country. (*Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 7 sitting Mondays after 1 September 2008.*)
- 14 **SAVE OUR SOLAR (SOLAR REBATE PROTECTION) BILL 2008** (*Mr Hunt*): Second reading (*from 23 June 2008*). (*Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 8 sitting Mondays after 1 September 2008.*)
- 15 **CLEANERS**: Resumption of debate (*from 23 June 2008—Ms Ley, in continuation*) on the motion of Mr Georganas—That the House:

  - (2) acknowledges that 200,000 people live with epilepsy at any one time in Australia and that up to three times as many Australians will have epilepsy at some time in their lives;
  - (3) that people living with epilepsy are disadvantaged by lack of research into the disorder and by the lack of a national plan for epilepsy or deeming it a disorder that is a national priority;
  - (4) acknowledges the impact that epilepsy has on the lives of people living with it;
  - (5) calls on the Australian Government to fund greater research into epilepsy; and
  - (6) calls on the Australian Government to establish a nationwide educational strategy on epilepsy modelled on the World Health Organisation's global campaign.   - (b) develop policies that promote workplace innovation, excellence and productivity including best practice models, codes of practice, awareness programs, business exchanges and awards; and

    - (a) microfinance has proven to be a particularly effective and sustainable means of eradicating poverty;
    - (b) microfinance borrowers, particularly women, generate income that allows them to feed, clothe, educate and care for the health of their children;
    - (c) in December 2006, 93 million of the poorest people had access to microfinance services, which is a 12-fold increase since 1997;
    - (d) in support of the poverty eradication goal of the Millennium Development Goals, the Microcredit Summit Campaign, launched in 1997, is working to expand microfinance to 175 million of the poorest people by 2015;
    - (e) the Microcredit Summit Campaign is holding an Asia-Pacific Microcredit Summit in Bali between the 29<sup>th</sup> and 30<sup>th</sup> July 2008;
    - (f) the Asia-Pacific region contains 64% of the world's population who live in absolute poverty, and as such it has a large unmet need for credit and other financial services; and
    - (g) the Bali Summit is a significant opportunity to examine ways to expand the use and effectiveness of microfinance in the region and to realise the Government's policy objective of reducing poverty in the Asia-Pacific region; and
  - (2) urges the Australian Government to send the appropriate Minister and appropriate Shadow Minister as leaders of an Australian delegation to the Asia-Pacific Microcredit Summit in Bali in July 2008. (*Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 5 sitting Mondays after 1 September 2008.*)
- 6 **OVARIAN CANCER:** Resumption of debate (*from 26 May 2008*) on the motion of Ms Owens—That the House:
- (1) that Ovarian Cancer Awareness Week will be held from 24 February to 2 March 2008;
  - (2) that ovarian cancer is the sixth most common cause of cancer death in women, with nearly 1,200 Australian diagnoses each year and nearly 800 Australian deaths from it each year;
  - (3) that when ovarian cancer is diagnosed at an early stage, the outlook is very good—as many as 90% of women diagnosed early are cured. However, 75% of women are diagnosed at the advanced stage when it is very difficult to treat;
  - (4) that it is a devastating disease that is difficult to diagnose early and treat at an advanced stage. A woman dies every 10 hours largely because of the lack of early detection tests and poor knowledge of the disease throughout the community;
  - (5) that a recent Senate Community Affairs inquiry into gynaecological cancer in Australia (tabled 27 February 2007) identified a need for increased awareness amongst the broader community about gynaecological cancers and symptoms and better educational support for general practitioners;
  - (6) that a survey commissioned by the National Breast Cancer Centre has revealed that half of all Australian women believe incorrectly that a pap smear will detect ovarian cancer and that 56% of women are unable to correctly name any signs or symptoms of the disease; and



- (7) the need for greater focus on education and additional research funding to help Australian scientists to find early detection markers and more effective treatments of this insidious disease. (*Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 5 sitting Mondays after 1 September 2008.*)

**7 BLOOD DONATION:** Resumption of debate (*from 2 June 2008*) on the motion of Mr Hayes—That the House:

- (1) recognises and celebrates the significant contribution which Australia's voluntary donors make to the Australian community as we approach World Blood Donor Day in June 2008;
- (2) recognises that whilst one in three people will at some stage require blood, presently only one in thirty people actually donate blood;
- (3) supports the efforts of the selfless individuals who give their blood to help save the lives and improve the health of people whom they may never meet;
- (4) congratulates the Australian Red Cross Blood Service for drawing attention to the need for more Australians to donate blood and celebrating the many generous and voluntary, unpaid blood donors who give blood each week to help those in need;
- (5) supports the efforts of the Minister for Health and Ageing and the Parliamentary Secretary to the Minister for Health and Ageing to increase the rate of blood donations in Australia; and
- (6) encourages members to actively encourage blood donation in their electorates. (*Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 6 sitting Mondays after 1 September 2008.*)

**8 BOTANY BAY AND THE KURNELL PENINSULA:** Resumption of debate (*from 2 June 2008*) on the motion of Mr Morrison—That the House:

- (1) recognises that:
  - (a) the Kurnell Peninsula of southern Sydney is the traditional land of the Gweagal people of the Dharawal nation;
  - (b) the landing site of Lieutenant James Cook on April 29, 1770 at Kurnell is the modern birthplace of our nation and is recognised on the National Heritage List;
  - (c) the village of Kurnell is a strong local community comprising approximately 700 homes;
  - (d) Botany Bay is a valuable marine environment providing sanctuary for migratory birdlife and habitat for territorial marine creatures; and
  - (e) construction of the desalination pipeline has commenced across Botany Bay from the Kurnell Peninsula, under approval as critical infrastructure by the New South Wales State Government;
- (2) expresses concern that:
  - (a) Part 3A of the *Environmental Planning and Assessment Act 1979* in New South Wales exempts critical infrastructure projects from all planning instruments and codes that might otherwise apply, precludes third party rights of appeal and limits powers and penalties in relation to enforcement of breaches of conditions;
  - (b) due to the use of Part 3A of the Act, the impacts of the construction of this pipeline on the marine environment and cultural heritage of Botany Bay and the Kurnell Peninsula are unknown; and
  - (c) since construction has commenced, there have been a series of breaches in relation to the failure of silt nets to contain land fill on Silver Beach at Kurnell; sheet piling testing has exceeded nominated noise vibration benchmarks, posing a threat to resident property; and there is concern in the community about the ongoing impacts and failures of this project; and
- (3) calls on the Minister for the Environment, Heritage and the Arts to protect the physical environment and cultural heritage of Botany Bay and the Kurnell Peninsula by requesting the New South Wales State Government to:
  - (a) prepare a comprehensive environmental remediation plan to address the impact of developing the desalination plant, including the pipeline across Botany Bay;
  - (b) conduct such environmental studies as are required to determine the impact of the development of the desalination plant and associated pipeline on the environment, and to make such studies available to the public;
  - (c) ensure that the development of environmental remediation plans is a requirement for any future referred approvals for critical infrastructure projects to the Commonwealth by the New South

Wales Government that are subject to Part 3A of the *Environmental Planning and Assessment Act 1979*;

- (d) prepare a heritage and community remediation plan that addresses the impact and disruption caused to residents and the area by the construction of the desalination plant and associated pipeline; and
  - (e) ensure the New South Wales State Government and its agents monitor and report on the ongoing impacts of the project and commit to informing residents in advance of any issues that may impact on residents or their local environment. (*Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 6 sitting Mondays after 1 September 2008.*)
- 9 **PLASTIC AND GLASS BOTTLES:** Resumption of debate (*from 2 June 2008*) on the motion of Mr Scott—That the House:
- (1) calls on the Federal Government to commit to ban by the year 2012 the inclusion of all plastic and glass bottles in landfill;
  - (2) notes the ban would be supported by implementation of a national program providing a cash refund for all plastic and glass bottles;
  - (3) calls on the Federal Government to reimburse grocery and convenience stores that provide collection sites for the empty bottles and provide cash refunds for each bottle, with larger bottles attracting a larger cash refund; and
  - (4) calls on the Federal Government to cooperate with local government bodies to ensure that smaller towns in rural, regional and remote Australia receive financial support to establish a collection centre and to transport bottles to the nearest recycling centre. (*Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 6 sitting Mondays after 1 September 2008.*)
- 10 **MENTAL HEALTH SERVICES:** Resumption of debate (*from 16 June 2008*) on the motion of Mr Pyne—That the House:
- (1) recognises the importance of providing state-of-the-art mental health care for the mentally ill;

  - (3) notes that mental health services in South Australia are under threat from the State Government with the proposed sale and redevelopment of the Glenside Campus. (*Order of the day will be removed from the Notice Paper unless re-accorded priority on any of the next 7 sitting Mondays after 1 September 2008.*)
- 11 **AUTISM:** Resumption of debate (*from 16 June 2008*) on the motion of Mr Hayes—That the House:
- (1) affirms its recognition that a combination of special education, speech therapy, occupational therapy and behavioural interventions has proved to be successful in helping people with an autism disorder;
  - (2) recognises early diagnosis and intervention is also essential to ensure families and carers have access to appropriate services and professional support;
  - (3) supports the Federal Government policy to establish specialised child care and early intervention services for children with autism; and
