4. PUBLIC SERVICE BILL.—The following Order of the Day was read and discharged :—

Public Service Bill—Consideration of Committee's Report.

- Sir William Lyne moved, That this Bill be now recommitted to a Committee of the whole House for the reconsideration of clauses 2, 5 (6), 6, 7, 8 (2), 9 (1), 10 (3), 13 (2), 19, 20 (1), 21, 28, 40, 44, 51, 52, 63, and 71, and the consideration of a new clause.

- Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.
- Mr. Speaker resumed the Chair; Mr. Chanter reported that the Committee had gone through the the Bill, and agreed to the same with further amendments.
- Ordered-That the Bill as further amended be printed, and taken into consideration on Tuesday next.
- 5. STATE LAWS AND RECORDS RECOGNITION BILL.-The Order of the Day for the second reading of this Bill having been read-Mr. Deakin moved, That this Bill be now read a second time. Debate ensued.
