- 13. Officers of Permanent Defence Forces.—Mr. Tudor (for Mr. Crouch) moved, pursuant to notice, That a Return be laid upon the Table of the House showing—
  - (1) The persons appointed since 1st January, 1901, as permanent commissioned officers of the defence forces of the Commonwealth and their present rank and salary and past service, excepting those appointed only for South African service and those who before that date were officers in the defence forces of the States.
  - (2) The number of officers of the permanent forces of the Commonwealth who have served in its permanent forces under the rank of commissioned officer.

14. Defence Forces—Retirement of Lieutenant-Colonels Braithwaite and Reay.—Mr. Chanter (for Mr. Hume Cook) moved, pursuant to notice, That a copy of all the papers and documents connected with the proposed retirement of Lieutenant-Colonels Braithwaite and Reay be laid upon the Table of the House.
