- 1. The House met pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. Petitions.—Mr. Glynn presented two Petitions from 152 electors and from 36 electors, respectively, of South Australia, praying that, in the measures proposed to be passed by the House for the government and control of British New Guinea, it will be enacted that the introduction, sale, and manufacture of intoxicating liquors shall be absolutely prohibited.

Petitions severally received.

3. Message from His Excellency the Governor-General.—Assent to Bill.—The following Message from His Excellency the Governor-General was presented by Sir George Turner, and the same was read by Mr. Speaker:—

A Bill intituled "An Act to grant and apply out of the Consolidated Revenue Fund a sum for the service of the year ending the thirtieth day of June One thousand nine hundred and four," as finally passed by the Senate and the House of Representatives of the Commonwealth, having been presented to the Governor-General for the Royal Assent, His Excellency has, in the name of His Majesty, assented to the said Act.
