MAY IT PLEASE YOUR EXCELLENCY-

We, the House of Representatives of the Parliament of the Commonwealth of Australia. in Parliament assembled, beg to express our loyalty to our Most Gracious Sovereign, and to thank Your Excellency for the Speech which you have been pleased to address to Parliament.

Mr. Gullett moved, That the Address be agreed to.

Mr. Aubrey Abbott seconded the motion.

Debate ensued.

Question--put and passed.

Mr. Earle Page (Treasurer) informed the House that he would ascertain when it would be convenient for His Excellency the Governor-General to receive the Address in Reply, and honorable Members would be notified accordingly.

6. Message from the Governor-General.—Estimates, 1925-26.—The following Message from His Excellency the Governor-General was presented, and the same was read by Mr. Speaker:--

STONEHAVEN,

Governor-General.

Message No. 1.

In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General transmits to the House of Representatives Estimates of Revenue and Expenditure for the year ending the thirtieth day of June, One thousand nine hundred and twenty-six, and recommends an appropriation of the Consolidated Revenue Fund accordingly.

Question—put and passed.—Bill read a first time.

Mr. Earle Page moved, That the Bill be now read a second time.

Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.
