- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment .--- Mr. Speaker (the Honorable Sir Littleton Groom) took the Chair, and read Prayers.
- 2. ELECTORAL ACT-JOINT SELECT COMMITTEE-REPORT.-Mr. Bowden (Chairman) brought up the Report from the Joint Select Committee on Electoral Law and Procedure, together with Minutes of Proceedings and Minutes of Evidence. Ordered to lie on the Table, and to be printed.

4. IMPERIAL CONFERENCE, 1926-SUMMARY OF PROCEEDINGS-MOTION FOR PRINTING OF PAPER.-Mr. Bruce (Prime Minister), by command of His Excellency the Governor-General, laid upon the Table the following Paper :-

Imperial Conference, 1926-Summary of Proceedings;

and moved, That the Paper be printed. Mr. Bruce, not having concluded his speech at the termination of the time allowed by Standing Order No. 257A, the Right Honorable Member was given leave to continue his speech.

Mr. Charlton moved, as an amendment, That all words after "That" be omitted with a view to the insertion of the following words in place thereof :-- ", in view of the State Governments' heavy financial responsibilities, the Bill be withdrawn ".

Debate continued.

Mr. Theodore moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed. Ordered—That the resumption of the debate be made an Order of the Day for the next sitting.

6. Message from the Senate.—Moving-picture Industry in Australia—Joint Select Committee.— Mr. Speaker announced the receipt of the following Message from the Senate :--

Message No. 69.

MR. SPEAKER,

The Senate transmits to the House of Representatives the following Resolution which was agreed to by the Senate this day, and requests the concurrence of the House of Representatives therein :-

" That-

- (1) a Joint Committee be appointed to inquire into and report on the moving-picture industry in Australia;
- (2) three Senators be appointed to serve on such Committee;
- (3) the Committee have power to send for persons, papers and records, to move from place to place, and sit during any adjournment of the Parliament;
- (4) a Message be sent to the House of Representatives requesting its concurrence, and asking that four Members of the House of Representatives be appointed to serve upon the said Committee."
