- 1. The House met, at eleven o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir Littleton Groom) took the Chair, and read Prayers.
- 2. Adjournment-Motion for Purpose of Discussion.—Mr. Charlton rose in his place, and said that he proposed to move the adjournment of the House for the purpose of discussing a definite matter of urgent public importance, namely, "The decision of the Federal Capital Commission to allow a private company to control the transport services of the Federal Territory."

Mr. Speaker thereupon called upon those Members who approved of the proposed discussion to rise in their places, and more than the necessary number of Members having risen accordingly---

Mr. Charlton moved, That the House do now adjourn.

Debate ensued.
