Mr. Latham moved, as an amendment, That after "may" (page 2, line 25) the words "if it thinks fit in all the circumstances of the case" be inserted.

Debate continued.

Progress to be reported, and leave asked to sit again.

The House resumed ; Mr. Mann reported accordingly. Resolved—That the House will, at the next sitting, again resolve itself into the said Committee.

3. ELECTORAL BILL (1927).—The Order of the Day having been read for the further consideration of this Bill in Committee of the whole House—Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Clause 2 debated and postponed.

Clauses 3 to 7 agreed to.

Clause 8—

On the motion of Mr. Blakeley, the following amendment was made :--

Page 3, line 28, after "Commonwealth;" insert "all Engineers engaged upon Railway or Road construction; all Mail Contractors;".

Clause, as amended, agreed to.

Clause.9-

Mr. Manning moved, as an amendment, That after "Officer" (page 4, line 24) the words "or Presiding Officer" be inserted.

Debate ensued.

Progress to be reported, and leave asked to sit again.

The House resumed; Mr. Bayley reported accordingly.
