- 3. ALTERATION OF DAY OF NEXT MEETING.—Mr. Scullin (Prime Minister) moved, That the House, at its rising, adjourn until Wednesday next at three o'clock p.m. Question—put and passed.
- 4. Constitution Alteration (Power of Amendment) Bill.—The Order of the Day having been read for the second reading—Mr. Scullin (Prime Minister) moved, That the Bill be now read a second time.

Mr. Latham moved, That the debate be now adjourned.

Question - That the debate be now adjourned—put and passed.

Ordered -That the resumption of the debate be made an Order of the Day for the next sitting.

5. Constitution Alteration (Industrial Powers) Bill.—The Order of the Day having been read for the second reading—Mr. Scullin (Prime Minister) moved, That the Bill be now read a second time

Mr. Latham moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered-That the resumption of the debate be made an Order of the Day for the next sitting.

6. Land Tax Assessment Bill (1930).—The Order of the Day having been read for the second reading—Mr. Theodore (Treasurer) moved, That the Bill be now read a second time.
