- 2. MINISTERIAL STATEMENT—OLD-AGE PENSIONS.—Mr. Lyons (Prime Minister), by leave, made a Ministerial Statement announcing certain Government decisions in regard to Old-age Pensions.
- 3. Ministerial Statement—Cotton-growing Industry.—Mr. White (Minister for Trade and Customs), by leave, made a Ministerial Statement in regard to the present position of the Cotton-growing Industry.
- ALTERATION OF DAY OF NEXT MEETING.—Mr. Lyons (Prime Minister) moved, That the House, at its rising, adjourn until Wednesday next at three o'clock p.m. Question—put and passed.

- 6. MINISTERIAL STATEMENT—TRADE AGREEMENT BETWEEN UNITED KINGDOM AND ARGENTINE REPUBLIC.—Mr. Frederick Stewart (Minister for Commerce), by leave, made a Ministerial Statement informing the House of further details of the Trade Agreement between the United Kingdom and the Argentine Republic.
- 7. Adjournment-Motion for Purpose of Discussion.—Mr. Thomas Paterson rose in his place, and said that he proposed to move the adjournment of the House for the purpose of discussing a definite matter of urgent public importance, namely, "The danger of substantial collapse of the exporting industries of the Commonwealth."

10. DISCHARGE OF ORDER OF THE DAY.—The following Order of the Day, General Business—

Sales Tax—Proposed Abolition—Resumption of debate upon the following motion of Mr. White:—That, in view of the following facts:—

(1) That the Sales Tax is a factor in keeping up the cost of living;

(2) That the Sales Tax is a harassing and irritating hindrance to trade and an indirect cause of unemployment;

(3) That there is (a) much unnecessary labour and trouble in rendering returns and making adjustments, (b) expense involved in securities paid, (c) misunderstanding regarding who and what are taxable;

(4) That there is large Government expenditure involved in labour and stationery in collecting the Sales Tax;

it is the opinion of this House that a Turnover Tax of 1½ per cent., which could be administered by the Income Tax Department and which would bring in equivalent revenue and make a large saving in administrative expenditure, be introduced for a period of two years, and the Sales Tax abolished—

was discharged, on the motion, by leave, of Mr. White.

11. Adjournment.—Mr. Lyons (Prime Minister) moved, That the House do now adjourn. Debate ensued.

Question—put and passed.
