Question—put and passed. Mr. Thorby then brought up the Bill accordingly, and moved, That it be now read a first time. Question—put and passed.—Bill read a first time. Ordered-That the second reading be made an Order of the Day for the next sitting. 9. ARBITRATION (PUBLIC SERVICE) BILL (1936).-The Order of the Day having been read for the second reading-Mr. Hughes (Minister representing the Acting Attorney-General) moved, That the Bill be now read a second time.
