Message No. 1.

In accordance with the requirements of Section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General transmits to the House of Representatives Estimates of Revenue and Expenditure for the year ending the thirtieth day of June, One thousand nine hundred and thirty-eight, and recommends an appropriation of the Consolidated Revenue Fund, accordingly.
