Stuart had carried out certain war operations.
- 3. EMPIRE AIR TRAINING AGREEMENT.—MINISTERIAL STATEMENT.—Mr. Fairbairn (Minister for Air), by leave, made a Ministerial Statement giving details of the organization under the Empire Air Training Agreement.
