1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable W. M. Nairn) took the Chair, and read Prayers.
2. CHRISTMAS LEAVE FOR TASMANIAN SOLDIERS—TRAVELLING ARRANGEMENTS—MINISTERIAL STATEMENT.—Mr. Forde (Minister for the Army), by leave, made a Ministerial Statement informing the House of the arrangements made for transport of and fare concessions to Tasmanian members of the Australian Imperial Force travelling from the mainland to Tasmania during Christmas leave.
3. PAPER.—The following Paper was presented, pursuant to Statute—
Dried Fruits Export Control Act—Seventeenth Annual Report of the Dried Fruits Control Board, for year 1940-41, together with Statement by Minister regarding the operation of the Act.
4. ARMY CENSORSHIP—MINISTERIAL STATEMENT—PRINTING OF PAPER.—Mr. Forde (Minister for the Army), by leave, made a Ministerial Statement with respect to the scope of the censorship of books and literature exercised by the Department of the Army, and referred to the duties performed by the honorable Member for Barker (Mr. Cameron) in the Censorship Section. Mr. Forde, by command of His Excellency the Governor-General, then laid upon the Table the following Paper:—

Mr. Fadden (Leader of the Opposition) moved, That the Paper be printed.

5. HAY INTERNMENT CAMP—MINISTERIAL STATEMENT.—Mr. Forde (Minister for the Army), by leave, made a Ministerial Statement with reference to the proposals for a sewerage scheme at the Hay Internment Camp, and informed the House of the appointment of a committee to consider the matter.
