- 2. DISTINGUISHED VISITORS.—Mr. Speaker informed the House that the Hon. D. G. Sullivan, M.P., Minister for Supply and Munitions, and the Rt. Hon. J. G. Coates, M.P., member of the War Cabinet, of New Zealand, were within the precincts. The distinguished visitors thereupon, with the concurrence of honorable Members, were provided with seats on the floor of the House.
- 3. NATIONAL SECURITY (ECONOMIC ORGANIZATION) REGULATIONS—MINISTERIAL STATEMENT.—Mr. Curtin (Prime Minister) presented the following Paper, pursuant to Statute:—

and, by leave, made a Ministerial Statement with regard to a proposal that a Committee of Members of the Parliament should be appointed to consider the effect of the Regulations. Mr. Fadden (Leader of the Opposition), by leave, also made a Statement in connexion with the proposal.

- 4. AIR RAIDS ON PORT MORESBY-MINISTERIAL STATEMENT.-Mr. Drakeford (Minister for Air), by leave, made a Ministerial Statement with reference to recent air raids on Port Moresby.
- 5. COAL-MINING INDUSTRY-MINISTERIAL STATEMENT.-Mr. Beasley (Minister for Supply and Development), by leave, made a Ministerial Statement in reference to the settlement of disputes in the Coal-mining Industry and the exercise of powers under the National Security (Coal Control) Regulations.
- 6. MINISTERIAL DUTIES.—Mr. Curtin (Prime Minister) announced that Mr. Holloway (Minister for Social Services and Minister for Health) would act as Assistant Minister for Munitions in lieu of Senator Cameron (Minister for Aircraft Production).
- 7. Assistance to Prime Minister.—Mr. Curtin (Prime Minister) announced that the Right Honorable Member for Yarra (Mr. Scullin) had agreed to act for and with the Prime Minister and Minister for Defence Co-ordination in a series of capacities.
- 8. ALTERATION OF DAY OF NEXT MEETING .- Mr. Curtin (Prime Minister) moved, That the House, at its rising, adjourn until Thursday, 5th March, at three o'clock p.m. Debate ensued. Question—put and passed.
