- 1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable W. M. Nairn) took the Chair, and read Prayers.
- 2. DISCHARGE OF ORDER OF THE DAY.—On the motion of Mr. Curtin (Prime Minister), by leave, the following Order of the Day, General Business, was discharged:—

- 3. WITHDRAWAL OF NOTICE OF MOTION .-- Mr. Lazzarini, by leave, withdrew Notice of Motion No. 1, General Business, standing in his name.
- 4. MESSAGE FROM THE GOVERNOR-GENERAL.—ASSENT TO BILLS.—The following Message from His Excellency the Governor-General was received, and was read by Mr. Speaker:--

Debate continued.

The Committee continuing to sit until after midnight-

Debate continued.

Ordered-That Mr. Riordan be granted extensions of time (2).

Ordered—That Mr. Rankin be granted extensions of time (2).

Debate continued.

Ordered—That Mr. James be granted extensions of time (2).

Debate continued.

Point of Order.—Sir Earle Page raised a Point of Order that the further speech just made by Mr. Chifley (Treasurer) did not necessarily exclude other honorable Members from addressing the Committee.

Chairman's Ruling.—The Chairman (Mr. Prowse) ruled that in accordance with the practice of the Committee such a speech would close the general debate, but that, in the circumstances, the honorable Member for Corangamite (Mr. McDonald) would be permitted to address the Committee. General debate continued.

Member named.—The Chairman named the honorable Member for Hunter (Mr. James) for disregarding the authority of the Chair.

Mr. James having expressed his regret, the matter was not further proceeded with.

General debate continued.

Point of Order.-Mr. Curtin (Prime Minister) raised a further Point of Order that the Treasurer, in his speech, was speaking in reply, and that in accordance with the practice of the Committee such a reply closed the general debate.

Debate ensued.

Chairman's Ruling.—The Chairman said that the Treasurer and the honorable Member for Corangamite rose simultaneously and that the call from the Chair had been given to the Minister. Had the Chair been aware that the Treasurer intended closing the debate, the call would have been given to the honorable Member for Corangamite. In the circumstances, Mr. McDonald was permitted to address the Committee after the Treasurer had spoken. The Treasurer having spoken in reply, in accordance with the practice of the Committee, the general debate was now closed.

First Item agreed to.

Progress to be reported, and leave asked to sit again.

The House resumed; Mr. Prowse reported accordingly.

Resolved-That the House will, at a later hour this day, again resolve itself into the said Committee.

Suspension of Sitting.—At twenty-two minutes past nine o'clock a.m., Mr. Speaker left the Chair. Resumption of Sitting .- At half-past two o'clock p.m., Mr. Speaker resumed the Chair.

The House resumed; Mr. Prowse reported accordingly.

Resolved-That the House will, at the next sitting, again resolve itself into the said Committee.

8. ADJOURNMENT.—Mr. Forde (Minister for the Army) moved, That the House do now adjourn. Question—put and passed.
