Mr. Sheehan moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered—That the resumption of the debate be made an Order of the Day for the next sitting.

- Time of Next Meeting.—Mr. Curtin (Prime Minister) moved, That the House, at its rising, adjourn until to-morrow at half-past two o'clock p.m. Question—put and passed.
- 7. Adjournment. -Mr. Curtin (Prime Minister) moved, That the House do now adjourn. Debate ensued.

And then the House, at twenty-nine minutes to eleven o'clock p.m., adjourned until to-morrow at half-past two o'clock p.m.
