WEDNESDAY, 18TH JULY, 1945.

- 1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable J. S. Rosevear) took the Chair, and read Prayers.
- 2. MINISTERIAL CHANGES.—Mr. Chifley (Prime Minister) informed the House that, following on the death of Mr. Curtin, His Royal Highness the Governor-General, on the 6th July, had commissioned Mr. Forde to form a Ministry to carry on the Government. The portfolios allotted were those previously held, with the exception of Mr. Beasley who had been appointed Minister for Defence in addition to the position of Vice-President of the Executive Council.

Mr. Chiffey also announced that, on the 13th July, following on his election as Leader of the Federal Parliamentary Labour Party, Mr. Forde resigned his office of Prime Minister, and that His Royal Highness had commissioned him to form a Ministry.

The Government is constituted as follows:—

Minister for Supply and Shipping Senator Ashley. Minister for Post-war Reconstruction and Minister in charge of the Council for Scientific and Industrial Research ... Mr. Dedman. . . Vice-President of the Executive Council Senator Collings. Minister for Transport and Minister for External Territories Mr. Ward. Minister for Health and Minister for Social Services Senator Fraser. Minister for Repatriation Mr. Frost. Minister for Works and Housing and Minister for Home Security Mr. Lazzarini. Postmaster-General Senator Cameron. Minister for Immigration and Minister for Information Mr. Calwell. . . Minister for the Interior Mr. Johnson.

Mr. Johnson will assist Mr. Lazzarini in his administration of the Department of Works and Housing. Pending the return to Australia of Mr. Evatt, Mr. Beasley and Mr. Makin will act for and on behalf of the Attorney-General and the Minister for External Affairs respectively.

Mr. Chifley indicated that the Members of the War Cabinet are—Mr. Chifley, Mr. Forde, Mr. Evatt, Mr. Beasley, Mr. Makin, Senator Keane, Mr. Drakeford and Mr. Dedman.

Mr. Chifley also announced that the Government will be represented on the Australian Advisory War Council by Mr. Chifley, Mr. Forde, Mr. Evatt, Mr. Beasley and Mr. Makin, and that the non-Government members will be Mr. Fadden, Mr. Hughes, Sir Earle Page, Mr. Spender and Mr. McEwen.

Senate Ministers will be represented in the House of Representatives as follows:—

- Mr. Forde will represent the Minister for Trade and Customs;
- Mr. Beasley will represent the Minister for Supply and Shipping;
- Mr. Holloway will represent the Minister for Health and the Minister for Social Services; and
- Mr. Calwell will represent the Postmaster-General.
- Mr. Menzies (Leader of the Opposition) and Mr. Fadden congratulated Mr. Chifley and Mr. Johnson.
- Mr. Chifley made acknowledgments.

3. Fremantle Electoral Division—Issue of Writ.—Mr. Speake: informed the House that he had this day issued a Writ for the Election of a Member to serve for the Electoral Division of Fremantle, in the State of Western Australia, in the place of the Right Honorable John Curtin, deceased. Message No. 15.

Mr. Menzies (Leader of the Opposition) moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.
Ordered—That the resumption of the debate be made an Order of the Day for the next sitting.

10. War Gratuity Bill 1945.—The Order of the Day having been read for the further consideration of this Bill in Committee of the whole House

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Clause 21-

Debate resumed on the amendment moved by Mr. Harrison, viz.:-That after paragraph (e) the following paragraph be inserted:-

"(f) a member who desires to establish or re-establish himself in civil life and who is entitled to receive the benefits provided in Division 3, Part VI., of the Re-establishment and Employment Act 1945,".

Amendment negatived.

Clause agreed to.

Clause 22-

Sir Frederick Stewart moved, as an amendment, That the words "to the War Service Homes Commissioner or any other authority approved by a prescribed authority "(page 11, lines 29-31) be omitted.

Debate ensued.

Amendment negatived.

Mr. Harrison moved, That the clause be omitted, and the following clause be inserted in place thereof:— "22. In approved cases, credit may be made available towards the cost of erection or purchase of a home for the member."

Debate continued.

Amendment negatived.

Mr. Spender moved, as an amendment, That after "authority" (page 11, line 30) the words "or person" be inserted. Question—That the amendment be agreed to—put.

11. Papua-New Guinea Provisional Administration Bill 1945.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time—Debate resumed by Mr. White who moved, as an amendment, That all words after "That" be omitted with a view to inserting the following words in place thereof :-- "the Bill be withdrawn and referred to a Select Committee for report as to whether the Bill meets the requirements of the Territories concerned, and to seek advice upon the best methods for restoring Civil Administration, for the welfare of the native population and for the economic development of Papua and New Guinea ".

Debate continued.

Mr. Cameron moved, That the debate be now adjourned.

Question-That the debate be now adjourned-put and passed.

Ordered-That the resumption of the debate be made an Order of the Day for the next sitting.
