1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable J. S. Rosevear) took the Chair, and read Prayers.
2. ALTERATION OF HOUR OF NEXT MEETING.—Mr. Chifley (Prime Minister) moved, That the House, at its rising, adjourn until to-morrow at half-past ten o'clock a.m.

3. COUNCIL OF FOREIGN MINISTERS, LONDON—MINISTERIAL STATEMENT.—Mr. Makin (Acting Minister for External Affairs), by leave, made a Ministerial Statement with reference to the presentation of the views of the Commonwealth Government at the discussions by the Council of Foreign Ministers in London of the terms for a peace settlement with Italy.

5. STATES GRANTS BILL 1945.—Mr. Chifley (Treasurer) moved, pursuant to notice, That he have leave to bring in a Bill for an Act to grant and apply out of the Consolidated Revenue Fund sums for the purposes of Financial Assistance to the States of South Australia, Western Australia and Tasmania.

Mr. Chifley then brought up the Bill accordingly, and moved, That it be now read a first time.
Question—put and passed.—Bill read a first time.
Mr. Chifley moved, by leave, That the Bill be now read a second time.
Mr. Menzies (Leader of the Opposition) moved, That the debate be now adjourned.
Question—That the debate be now adjourned—put and passed.
Ordered—That the resumption of the debate be made an Order of the Day for the next sitting.
6. POSTPONEMENT OF BUSINESS.—Ordered—That the intervening Business be postponed until after Notice of Motion No. 1, General Business.
7. CHAIRMAN OF COMMITTEES—WANT OF CONFIDENCE MOTION.—Mr. Menzies (Leader of the Opposition) moved, pursuant to notice, That the Chairman of Committees does not possess the confidence of this House.
