EXTENSIONS TO CITY WEST TELEPHONE EXCHANGE, MELBOURNE-APPROVAL OF WORK .-- Mr. Lemmon (Minister for Works and Housing) moved, pursuant to notice, That, in accordance with the provisions of the Commonwealth Public Works Committee Act 1913-1947, it is expedient to carry out the following proposed work which was referred to the Parliamentary Standing Committee on Public Works and on which the Committee has duly reported to this House the results of its investigations, namely :--Extensions to the City West Telephone Exchange, Melbourne. Debate ensued.

- 5. SUPPLY BILL (No. 1) 1949-50.-The Order of the Day having been read for the further consideration of this Bill in Committee of the whole House-
  - Mr. Deputy Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Mr. Harrison moved, That the debate be now adjourned. Question-That the debate be now adjourned-put and passed. Ordered-That the resumption of the debate be made an Order of the Day for the next sitting.
- 9. SUPPLY BILL (No. 1) 1949-50.-The Order of the Day having been read for the further consideration of this Bill in Committee of the whole House-Mr. Deputy Speaker left the Chair, and the House again resolved itself into a Committee of the Whole.
