NEW HOUSE OF COMMONS, WESTMINSTER-INVITATION TO OPENING.-Mr. Speaker informed the House that he had received a letter from the Right Honorable the Speaker of the House of Commons conveying the desire of the United Kingdom Government and the Speaker that this House should be represented at the opening of the new House of Commons on the 26th October. Mr. Speaker then laid upon the Table the following Paper :-

- 3. South and South-East Asia-British Commonwealth Consultative Committee Conference-MINISTERIAL STATEMENT-MOTION FOR PRINTING PAPER.-Mr. Spender (Minister for External Affairs), by leave, made a Ministerial Statement informing the House of the main topics discussed and the more important decisions taken at the meeting of the British Commonwealth Consultative Committee, held at Sydney in May, to consider the economic and production problems of South and South-East Asia. Mr. Spender then, by command of His Excellency the Governor-General, laid upon the Table the following Paper :-

OPEN-CUT COAL PRODUCTION .- Mr. Wentworth moved, pursuant to notice, That, in the opinion of this House, the Federal Government's efforts to increase the production of open-cut coal in Australia should be continued and intensified; and, further, that the present underhand sabotage of open-cut coal production by the New South Wales Labour Government should be checked as far as possible.

Debate ensued.
