 Mr. White (Minister for Air) moved, That the debate be now adjourned.

Clause 10 debated and agreed to. Clause 11 debated and agreed to. Clause 12 agreed to. Schedule agreed to. Title agreed to. Bill to be reported without amendment.

The House resumed ; Mr. McDonald reported accordingly. On the motion of Mr. Fadden (Treasurer), the House adopted the Report, and (the Standing Orders having previously been suspended, see page 252), the Bill was read a third time.
