5. Income Tax and Social Services Contribution Assessment Bill 1954—Senate's Amendments. The Order of the Day having been read for the consideration in Committee of the whole House of the Amendments made by the Senate in this Bill—
Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

The Committee proceeded to consider the Amendments, which are as follows:— Schedule of the Amendments made by the Senate. No. 1.—Page 3, after clause 6, insert the following clause:—

"6A. Section sixty-three of the Principal Act is amended by omitting from sub-Bad debts. section (2.) the words 'is adjudicated bankrupt' and inserting in their stead the words 'becomes a bankrupt'."

- No. 2.—Page 4, after clause 7, insert the following clause:—

  "7A. Section eighty of the Principal Act is amended by omitting sub-section (4.) Losses of previous years. and inserting in its stead the following sub-section:—

  (4.) Notwithstanding any other provision of this section, where, prior to the year of income,
  - a taxpayer has become a bankrupt, or, not having become a bankrupt, has been released from any debts by the operation of the Bankruptcy Act 1924 or that Act as amended, no loss incurred by him prior to the date on which he became a bankrupt or the date on which he was so released, as the case may be, shall be an allowable deduction.'.'.

Mo. 3.—Page 6, after clause 9, insert the following clause:—

"9A. Section two hundred and twenty-one of the Principal Act is amended by Payment of omitting from sub-paragraph (i) of paragraph (b) of sub-section (1.) the words 'the date priority over of the order of sequestration' and inserting in their stead the words 'the date on which all other taxes. he became a bankrupt'.".
