1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable J. McLeay) took the Chair, and read Prayers.
2. PETITION.—Mr. McIvor presented a Petition from certain citizens of Australia praying that immediate consideration be given to the matter of increasing the rate of age, invalid and widows' pensions to at least 50 per cent. of the basic wage.  
Petition received and read.
3. PAPERS.—The following Paper was presented, by command of His Excellency the Governor-General—

5. SUSPENSION OF STANDING ORDERS—EXTENDED TIME FOR SPEECHES.—Mr. H. E. Holt (Minister for Labour and National Service) moved, by leave, That so much of the Standing Orders be suspended as would prevent Mr. Menzies (Prime Minister) speaking without limitation of time, and Mr. Ward speaking for a period not exceeding 45 minutes, on the Budget.  
Question—put and passed.
6. SUPPLY—BUDGET DEBATE.—The House, according to Order, resolved itself into the Committee of Supply.

*(In the Committee.)*

General debate resumed on the question, That the first item in the Estimates, under Division No. 1—  
Senate—namely—

Salaries and allowances	..	..	..	..	£30,000

be agreed to, and on the Amendment moved thereto by Mr. Evatt (Leader of the Opposition), viz.:—  
That the first item be reduced by £1.

Progress to be reported, and leave asked to sit again.

The House resumed; Mr. Adermann reported accordingly.

Resolved—That the House will, at the next sitting, again resolve itself into the said Committee.

7. ADJOURNMENT.—Mr. H. E. Holt (Minister for Labour and National Service) moved, That the House do now adjourn.  
Question—put and passed.
