DISCUSSION OF MATTER OF URGENCY—PHYSICALLY HANDICAPPED EMPLOYEES.—Mr. Luchetti having proposed to Mr. Speaker that a definite matter of urgent public importance be submitted to the House for discussion, namely, "Recent dismissals of certain physically handicapped employees from Commonwealth Government establishments and the need to devise a plan for the employment of handicapped persons"—

 Mr. Luchetti addressed the House.

GENEVA CONVENTIONS BILL 1957.—Mr. Casey (Minister for External Affairs), for Sir Philip McBride (Minister for Defence), moved, pursuant to notice, That he have leave to bring in a Bill for an Act to enable effect to be given to certain Conventions done at Geneva on the twelfth day of August, One thousand nine hundred and forty-nine, and for related purposes.

Question—put and passed.

Mr. Casey then brought up the Bill accordingly, and moved, That it be now read a first time.

Mr. Casey moved, by leave, That the Bill be now read a second time.
