### TUESDAY, 26TH AUGUST, 1958.

- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable J. McLeay) took the Chair, and read Prayers.
- 2. MINISTERIAL ARRANGEMENTS.—Mr. Menzies (Prime Minister) informed the House that during the absence abroad of Mr. McEwen, Mr. Townley (Minister for Supply) would act as Minister for Trade.
- 3. PAPERS.—The following Papers were presented, pursuant to Statute—
  - Cellulose Acetate Flake Bounty Act-Return for year 1957-58.
  - Cotton Bounty Act-Return for 1957.
  - Public Service Act-Appointments-Department-
    - Interior--R. R. Morcom.
    - Primary Industry-H. W. Chapman.
    - Works-I. F. Burston.
  - Public Service Arbitration Act—Determination—1958—No. 115—Amalgamated Engineering Union and others.

4. NATIONALITY AND CITIZENSHIP BILL 1958.—Mr. Downer (Minister for Immigration) moved, pursuant to notice, That he have leave to bring in a Bill for an Act to amend the *Nationality and Citizenship Act* 1948–1955.

Question—put and passed.

Mr. Downer then brought up the Bill accordingly, and moved, That it be now read a first time.

Question-put and passed.-Bill read a first time.

Mr. Downer moved, by leave, That the Bill be now read a second time.

- Debate adjourned (Mr. Calwell), and the resumption of the debate made an Order of the Day for the next sitting.
- 5. CHRISTMAS ISLAND BILL 1958.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time—

Debate adjourned (Mr. Cramer-Minister for the Army), and the resumption of the debate made an Order of the Day for the next sitting.

6. SUPPLY--ESTIMATES 1958-59.—The House, according to Order, resolved itself into the Committee of Supply.

(In the Committee.)

Remainder of Vote—" Parliament,  $\pounds 1,082,000$  "—debated and agreed to. Vote—" Prime Minister's Department,  $\pounds 2,931,000$  "—debated and agreed to. Progress to be reported, and leave asked to sit again.

The House resumed; Mr. Bowden reported accordingly. Resolved—That the House will, at the next sitting, again resolve itself into the said Committee.
