### THURSDAY, 23RD APRIL, 1964.

- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir John McLeay) took the Chair, and read Prayers.
- 2. Petition.—Mr. Hansen presented a petition from certain electors of the Commonwealth praying that the Commonwealth Government immediately grant a basic pension rate of £8 10s. per week, formulate a national housing plan for low rental homes for pensioners and provide all pensioners within the permissible income with the medical entitlement card.

  Petition received and read.
- 3. Questions.—Questions without notice were asked.
- 4. PAPER.—The following paper was presented, pursuant to statute— Canned Fruits Export Control Act—Australian Canned Fruits Board—Thirty-eighth and Final Report, for period 1st July to 31st December, 1963, together with Statement by Minister regarding the operation of the Act.
- 5. Joint Select Committee on Parliamentary and Government Publications—Extended time for Report.—Mr. McMahon (Minister for Labour and National Service) moved, by leave—
  - (1) That the time for bringing up the report of the Joint Select Committee on Parliamentary and Government Publications be extended to the 14th May, 1964.
  - (2) That a message be sent to the Senate requesting its concurrence. Question—put and passed.
- 6. Special Adjournment.—Mr. McMahon (Minister for Labou: and National Service) moved, That the House, at its rising, adjourn until Tuesday, the 5th May, at half-past two o'clock p.m. Question—put and passed.

RESTRAINTS UPON PUBLIC STATEMENTS BY MEMBERS.—Mr. Turner moved, pursuant to notice, That this House condemns the action of persons and organizations having no direct responsibility to the Australian electorate in issuing instructions to elected Members of the Australian Parliament that they refrain from publicly expressing views held by them on issues affecting the safety of this country. Debate ensued.

The time allotted for precedence to general business having expired, the debate was interrupted, Mr. Whitlam was granted leave to continue his speech when the debate is resumed, and the resumption of the debate was made an order of the day for the next sitting.
