Sandford, and moved, That this House expresses its deep regret at the death of Senator Charles Walter Sandford, a Senator from the State of Victoria, places on record its appreciation of his meritorious public service and tenders its profound sympathy to his family in their bereavement.

- PETITION.—Mr. Mortimer presented a petition from certain citizens of Australia praying that the Australian Government increase by a considerable amount its contributions to non-military overseas aid, such aid to be financed, if necessary, by increases in taxation, administered by some international organization such as the United Nations and offered to countries without reference to political advantage or purposes, but solely on the basis of need.
