1. The House met, at half-past nine o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir John McLeay) took the Chair, and read Prayers.
2. PAPER.—Mr. Wentworth, by leave, presented the following paper:—  
Copy of statutory declaration made by Stanislaus Thomas Kelly of 20 Grassmere Street, Guildford, New South Wales, dated 26th October, 1966, concerning Mr. Sam Lewis of the Teachers' Federation.
3. QUESTIONS.—Questions without notice were asked.
4. PAPER.—The following paper was presented, pursuant to statute—  
International Monetary Agreements Act—Annual Report on operations of the Act, and insofar as they relate to Australia, of the International Monetary Fund Agreement and the International Bank Agreement, for year 1965-66.

5. MANILA SUMMIT CONFERENCE—MINISTERIAL STATEMENT—MOTION TO TAKE NOTE OF PAPER.—The order of the day having been read for the resumption of the debate on the following motion of Mr. Holt (Prime Minister):—That the House take note of the paper (*presented on the 27th October, 1966*), viz.:—  
Manila Summit Conference—Ministerial statement, 27th October, 1966—  
*Suspension of standing orders—Extended time for speech.*—Mr. Fairbairn (Minister for National Development) moved, by leave, That so much of the standing orders be suspended as would prevent Mr. Calwell (Leader of the Opposition) speaking without limitation of time.  
Question—put and passed.  
Debate resumed.  
Debate adjourned (Mr. Peacock), and the resumption of the debate made an order of the day for the next sitting.
6. MESSAGE FROM THE SENATE—PAPUA AND NEW GUINEA BILL 1966.—Mr. Speaker reported the receipt of the following message from the Senate:—

The Senate returns to the House of Representatives the Bill for "*An Act to amend the 'Papua and New Guinea Act 1949-1964'*", and acquaints the House that the Senate has agreed to the Bill with the amendment indicated by the annexed Schedule, in which amendment the Senate requests the concurrence of the House of Representatives.

## SCHEDULE OF THE AMENDMENT MADE BY THE SENATE.

Page 5, clause 10, after sub-section (8.) of proposed section 62A insert the following sub-section:—

"(8A.) Where the Governor-General disallows any Rules of Court or part of any Rules, the Minister shall cause a statement of the reasons for the disallowance to be laid before each House of the Parliament as soon as possible, but in any case within fifteen sitting days of that House after the date of disallowance."

On the motion of Mr. Barnes (Minister for Territories), the amendment was agreed to, after debate.  
Resolution to be reported.

The House resumed; Mr. Lucock reported accordingly.  
On the motion of Mr. Barnes, the House adopted the report.
