- 2 Petitions: Mr Corbett presented a petition from certain electors of the Division of Maranoa praying that the Government convey as urgently as possible its belief to our American allies that all aspects of the war in Vietnam should be intensified, while pursuing a policy of no compromise at the current Paris talks.

Petition received and read.

- A similar petition was presented by Mr Bowen (Attorney-General), from certain electors of the Commonwealth, and was received.
- 3 QUESTIONS: Questions without notice were asked.

- 15 TELEPHONE EXCHANGE BUILDING, HAWTHORN, VIC.—APPROVAL OF WORK: Mr Kelly (Minister representing the Minister for Works) moved, pursuant to notice—That, in accordance with the provisions of the Public Works Committee Act 1913-1966, it is expedient to carry out the following proposed work which was referred to the Parliamentary Standing Committee on Public Works and on which the committee has duly reported to this House: Hawthorn, Vic.-Extension to telephone exchange building. Question—put and passed.
