## TUESDAY, 7 APRIL 1970

- 1 The House met, at half-past two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 DEATH OF MEMBER (MR J. R. FRASER): Mr Gorton (Prime Minister) referred to the death of Mr J. R. Fraser, and moved—That this House expresses its deep regret at the death on 1 April 1970 of James Reay Fraser, a Member of this House for the Australian Capital Territory, places on record its appreciation of his long and meritorious public service and tenders its profound sympathy to his widow and family in their bereavement.
  - And Mr Whitlam (Leader of the Opposition) having seconded the motion, and Mr McEwen (Leader of the Australian Country Party) and other honourable Members having addressed the House in support thereof, and all Members present having risen, in silence—

Question—passed.

- 3 Suspension of sitting as Mark of Respect: As a mark of respect to the memory of the deceased Member, the sitting was thereupon suspended until eight o'clock p.m.
- 4 RESUMPTION OF SITTING: At eight o'clock p.m., the Chair was resumed by the Deputy Speaker (Mr Lucock).
- 5 Petitions: Mr Calwell presented a petition from certain residents of Victoria praying that the export of all kangaroo products be banned immediately.
  - Mr Luchetti presented a petition from certain electors of New South Wales praying that immediate action be taken to grant War Service Homes rights to all wartime exservicewomen.

Petitions severally received and read.

- 6 MINISTERIAL ARRANGEMENTS: Mr Gorton (Prime Minister) informed the House that, during the respective absences abroad of Mr Bury (Treasurer) and Mr J. M. Fraser (Minister for Defence), he would act as Treasurer and Mr Hulme (Postmaster-General) would act as Minister for Defence and represent the Minister for Supply in this House.
- 7 QUESTIONS: Questions without notice being asked—

Mr McMahon (Minister for External Affairs) answering a question-

Closure of Member moved: Mr Uren moved—That the Right Honourable Member be not further heard.

Question—put and negatived.

Questions without notice continued.

- 9 Crown of Thorns starfish—Appointment of committee of inquiry—Ministerial statement: Mr Gorton (Prime Minister), by leave, made a ministerial statement informing the House of the appointment of a joint Commonwealth-Queensland committee to investigate the problem of the Crown of Thorns starfish.
- 10 AUSTRALIAN AID TO INDONESIA—MINISTERIAL STATEMENT: Mr McMahon (Minister for External Affairs), by leave, made a ministerial statement informing the House of Australia's proposed economic assistance to Indonesia for the three year period 1970-71 to 1972-73.

Mr Whitlam (Leader of the Opposition), by leave, also made a statement with reference to the matter.

12 NATIONAL LIBRARY COUNCIL: Mr Peacock (Minister assisting the Prime Minister) moved, by leave—That, in accordance with the provisions of the *National Library Act* 1960-1967, this House elects Mr Bryant to be a member of the Council of the National Library of Australia and to continue as a member for a period of three years from this day.

Debate ensued.

14 FOREIGN AFFAIRS—MINISTERIAL STATEMENT—MOTION TO TAKE NOTE OF PAPER: The order of the day having been read for the resumption of the debate on the motion of Mr McMahon (Minister for External Affairs)—That the House take note of the paper (presented on 19 March), viz.:
