- 1 The House met, at half-past ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 RETURN TO WRIT—CHISHOLM DIVISION: Mr Speaker announced that he had received a return to the writ which he had issued on 13 August for the election of a Member to serve for the Electoral Division of Chisholm, in the State of Victoria, to fill the vacancy caused by the death of the Honourable Sir Wilfrid Selwyn Kent Hughes, K.B.E., M.V.O., M.C., E.D., and that by the endorsement on the writ, it was certified that Anthony Allan Staley had been elected.
- 3 MEMBER SWORN: Anthony Allan Staley was introduced, and made and subscribed the oath required by law.
- 4 PETITIONS: Mr Bennett presented a petition from certain citizens of Australia praying that this House take immediate steps to abolish the means test for all people who have reached retiring age or who otherwise qualify for social service benefits or pensions.
 - Mr Enderby presented a petition from certain citizens of Australia praying that the House seek to ensure that Commonwealth legislation bearing on films, literature and radio and television programmes is so framed and so administered as to give the maximum freedom to adults to choose what they will watch, read and listen to, even in the face of pressure from those who seek to impose their ideas and morals on others who do not share them.

Petitions severally received and read.

- Similar petitions to that presented by Mr Enderby were presented by Mr MacKellar and Mr Chipp (Minister for Customs and Excise), and were severally received.
- Mr Fox presented a petition from certain residents of Victoria praying that the export of products made from kangaroos be banned and the Commonwealth Government take necessary steps to have all wildlife in Australia brought under its control.
- Mr Garrick presented a petition from certain citizens of Australia praying that the Government will seek the co-operation of the States and supply extra finance to the States to enable (1) proper town planning and development to halt the increase in densely populated areas which lead to increased crime, (2) the proper staffing and equipping of police forces to enable adequate crime prevention and detection measures to reduce the frightening increase of both solved and unsolved crime, (3) the proper detention of and rehabilitation of criminals and (4) compensation to victims of crimes of violence.

Petitions severally received and read.

A similar petition to that presented by Mr Garrick was presented by Mr Martin, and was received.

5 QUESTIONS: Questions without notice being asked-

- Member named and suspended: Mr Speaker named the honourable Member for Dawson (Mr Patterson) for refusing to withdraw unreservedly an unparliamentary remark.
- Mr Snedden (Leader of the House) moved—That the honourable Member for Dawson be suspended from the service of the House.
- The House proceeded to divide, but the Tellers appointed for the "Noes" refusing to act, Mr Speaker declared the question resolved in the affirmative.
- The honourable Member was, therefore, suspended at one minute past eleven o'clock a.m. for twenty-four hours under standing order 305, and he accordingly withdrew from the Chamber.
- Member named: Mr Speaker named the honourable Member for Sydney (Mr Cope) for refusing to apologise for disorderly conduct during the division proceedings.
- Mr Snedden moved—That the honourable Member for Sydney be suspended from the service of the House.
- Mr Whitlam (Leader of the Opposition) having addressed the Chair, and Mr Cope having apologised to the Chair for his disorderly conduct, the motion for the suspension of the honourable Member for Sydney was withdrawn, by leave.
- Suspension of standing orders moved: Mr Bryant moved—That so much of the standing orders be suspended as would prevent a discussion on the question in dispute between Members of the Opposition and the Minister for the Interior.

Debate ensued.

Debate adjourned (Mr Crean), and the resumption of the debate made an order of the day for the next sitting.

13 STATES GRANTS (CAPITAL ASSISTANCE) BILL 1970: Mr Lynch (Minister assisting the Treasurer), pursuant to notice, presented a Bill for an Act to grant Financial Assistance to the States in connexion with Expenditure of a Capital Nature and to Authorize the Borrowing of Moneys by the Commonwealth for the purpose of that Assistance. Bill read a first time.

Mr Lynch moved—That the Bill be now read a second time.

- Debate adjourned (Mr Crean), and the resumption of the debate made an order of the day for the next sitting.
- 14 APPROPRIATION BILL (No. 1) 1970-71: The House, according to order, resolved itself into a committee of the whole for the further consideration of the Bill.

15 SUSPENDED MEMBER—RE-ADMISSION TO HOUSE: Mr Patterson, by indulgence of Mr Speaker, returned to the Chamber and referred to the incident this morning when he had been suspended. Mr Patterson stated that, owing to a misunderstanding, he had not complied with the Speaker's direction to withdraw a remark unreservedly. He now withdrew the remark unreservedly and expressed his regret.

Mr Speaker stated that, in view of the remarks of the honourable Member, he would have no objection to a motion being moved to allow the honourable Member to resume his part in the proceedings of the House.
