- 1 The House met, at half-past two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 Petitions: Mr Klugman presented a petition from certain residents of the Australian Capital Territory praying that a Committee of Inquiry, on which are represented the Department of Education and Science, institutions of tertiary education, practising educators, and the Canberra community, be instituted to inquire into the form that an Australian Capital Territory Education Authority should take, the educational principles and philosophy that should underly it, and its mode of operation and administration.
 - Mr L. R. Johnson presented a petition from certain citizens of Australia praying that the Government will (a) ban the shooting of kangaroos for commercial purposes, (b) ban the export of all kangaroo products from Australia, (c) prevent the extinction of the red kangaroo, (d) institute a scientific survey of the kangaroo population, (e) establish large national parks of good quality land as major tourist attractions and (f) take control of and be completely responsible for the management of Australia's wildlife.

Petitions severally received and read.

Mr Fox presented a petition from certain residents of Victoria praying that the export of products made from kangaroos be banned and the Commonwealth Government take necessary steps to have all wildlife in Australia brought under its control. Petition received.

- 4 PAPUA AND NEW GUINEA—CONSTITUTIONAL DEVELOPMENT—MINISTERIAL STATEMENT—MOTION TO TAKE NOTE OF PAPER: Mr Barnes (Minister for External Territories), by leave, made a ministerial statement with reference to proposed changes in constitutional arrangements for the Territory of Papua and New Guinea arising out of the recommendations of the Papua and New Guinea House of Assembly Select Committee on Constitutional Development which were adopted by the House of Assembly on 11 March 1971, and, by command of His Excellency the Governor-General, presented the following paper:
