- 1 The House met, at half-past ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 Petitions: Mr Fairbairn (Minister for Defence) presented a petition from certain citizens of the Commonwealth praying that this House make legal provision for (1) the allowance of personal education expenses as a taxation deduction, (2) the removal of the present age limit in respect of the deduction for education expenses, (3) an increase in the deduction allowable for tertiary education expenses and (4) the exemption of non-bonded scholarships for part-time students from income tax.

Petition received.

Mr Bryant presented a petition from certain electors of Victoria praying that this House will repeal the National Service Act, remove from the record all convictions made under it, and cause Charles Martin and Geoffrey Mullen, and all others imprisoned under it, to be released and cease all further prosecutions under it.

Petition received and read.

Mr Bryant informed the House that he proposed to take action in connection with the petition, and moved—That the petition be printed.

Ouestion—put and passed.

Mr Hurford, Mr Birrell and Mr Nicholls presented petitions from certain electors of South Australia praying that this House will repeal the National Service Act, and cause Charles Martin, and all others imprisoned under it, to be released.

Petitions severally received.

Mr Enderby presented a petition from certain residents of Australia praying that this House will take steps to appoint a Standing Committee which will (a) consider all petitions presented to the House and (b) recommend to the House any action which it thinks should be taken with respect to them.

Petition received and read.

- Mr England and Mr Robinson presented petitions from certain electors of Australia praying that the Government revise its interpretation of the Geneva Protocol of 1925 relating to chemical agents of warfare, and declare that it regards all chemical substances employed for their toxic effects on man, animals or plants, as being included in the prohibitions laid down by that Protocol.
- Mr Cohen and Mr James presented petitions from certain citizens of Australia praying that the Government increase immediately pensions by \$5.00 per week, child endowment to \$3.60 per week per child and the maternity allowance to at least \$117.00 for each child born.

Petitions severally received.

Mr Enderby presented a petition from certain students of Class 6L of Griffith Primary School in the Australian Capital Territory praying that this House will take immediate steps to provide them with teachers for high school.

Petition received and read.

- Mr Kirwan presented a petition from certain citizens of Australia praying that this House give earnest consideration to the crisis in Aboriginal welfare which exists in the South West Land Division of Western Australia.
- Mr Gun presented a petition from certain citizens of the Commonwealth praying that the Federal Government and all State Governments recognise the right of Aboriginal people of Australia to own and control certain lands and be paid compensation for lands lost and that the Australian people inform themselves as to the present conditions of Aborigines on reserves in Australia.

Petitions severally received.

- 3 QUESTIONS: Questions without notice were asked.
- 4 STATEMENT BY MEMBER—LEAVE TO MAKE NOT GRANTED: Mr Hurford asked leave to make a statement.

Objection being raised, leave not granted.

5 Suspension of standing orders moved: Mr Scholes moved—That so much of the standing orders be suspended as would prevent the honourable Member for Adelaide making a statement.

- 18 APPROPRIATION BILL (No. 1) 1971-72—BUDGET DEBATE: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—And on the amendment moved thereto by Mr Whitlam (Leader of the Opposition), viz.—That all words after "That" be omitted with a view to inserting the following words in place thereof: "the House condemns the Budget because (a) it breaks the Prime Minister's pledge to Parliament on taking office to bring into effect for 1971-72 a fundamental review of social services and of methods for adjusting them, (b) it contains no proposals to balance the finances and functions of the Commonwealth, the States and local government and (c) it produces no programmes for high national objectives of social welfare, economic strength and national security"—Debate resumed.

Count-out: Mr Gun called the attention of the Deputy Speaker (Mr Lucock) to the fact that a quorum of Members was not present.

The bells having been rung, and a quorum not having been obtained within the prescribed time, Mr Deputy Speaker thereupon, at seven minutes to five o'clock p.m., adjourned the House until Tuesday, 7 September, at half-past two o'clock p.m.
