FRIDAY, 10 SEPTEMBER 1971

- 1 The House met, at half-past ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 PETITIONS: Mr McMahon (Prime Minister) presented a petition from certain citizens of Australia praying that this House should cause the Australian Government to recognise the right of Australian professional people engaged in the creative and performing arts to further develop their skills and talents in Australia, and to be protected from overseas programmes in a way that will encourage an Australian television and radio industry.
 - Mr Fox presented a petition from certain residents of New South Wales praying that the export of all kangaroo products be banned immediately.
 - Mr Jones presented a petition from certain citizens of the Commonwealth praying that this House make legal provision for (1) the allowance of personal education expenses as a taxation deduction, (2) the removal of the present age limit in respect of the deduction for education expenses, (3) an increase in the deduction allowable for tertiary education expenses, (4) an increase in the maintenance allowance for students and (5) the exemption of non-bonded scholarships for part-time students from income tax.
 - Mr Sherry presented a petition from certain electors of Australia praying that the Government revise its interpretation of the Geneva Protocol of 1925 relating to chemical agents of warfare, and declare that it regards all chemical substances employed for their toxic effects on man, animals or plants, as being included in the prohibitions laid down by that Protocol.
 - Mr Klugman presented a petition from certain residents of the Australian Capital Territory praying that a Committee of Inquiry, on which are represented the Department of Education and Science, institutions of tertiary education, practising educators, and the Canberra community, be instituted to inquire into the form that an Australian Capital Territory Education Authority should take, the educational principles and philosophy that should underly it, and its mode of operation and administration.
 - Mr Foster presented a petition from certain electors of the Division of Sturt praying that section twenty-six of the National Service Act be repealed.

Petitions severally received.

3 MINISTERIAL ARRANGEMENTS AND APPOINTMENT OF ASSISTANT MINISTERS: Mr McMahon (Prime Minister) informed the House that Mr Holten, in addition to his duties as Minister for Repatriation, would assist the Minister for Trade and Industry. Mr McMahon also informed the House of the following appointments of Assistant Ministers:

Mr Dobie to assist the Prime Minister;

Mr King to assist the Minister for Primary Industry;

Senator Marriott to assist the Minister for Health and Leader of the Government in the Senate:

L Į.

Mr Robinson to assist the Postmaster-General;

Mr Street to assist the Minister for Labour and National Service, and

Mr McLeay to assist the Minister for Civil Aviation.

- Mr McMahon stated that Senator Marriott and Mr King would take up their duties after they had been sworn as Members of the Executive Council.
- Mr McMahon further informed the House that, during the absence overseas of Senator Wright, Mr Chipp (Minister for Customs and Excise) would act as Minister for Works and be represented in the Senate by Senator Anderson (Minister for Health).
- 4 QUESTIONS: Questions without notice were asked.
- 5 SUSPENSION OF STANDING ORDERS MOVED-MOTION WITHOUT NOTICE: Mr Armitage moved-That so much of the standing orders be suspended as would prevent this House considering a motion at this time to establish a select committee to inquire into and report on the allocation of land to Ministers of the Crown on which are built houses at Government expense and which enables them to make undisclosed profits.

Debate ensued.

Mr Enderby, by leave, also made a statement with reference to the matter.

8 LIBRARY COMMITTEE: Mr Swartz (Leader of the House) moved, by leave—That Mr Robinson be discharged from attendance on the Library Committee, and that, in his place, Mr O'Keefe be appointed a member of the committee.

Question-put and passed.

9 PUBLIC WORKS COMMITTEE—REFERENCE OF WORK—SCHOOLS AT ALICE SPRINGS AND DARWIN, N.T.: Mr Chipp (Acting Minister for Works) moved, pursuant to notice— That, in accordance with the provisions of the *Public Works Committee Act* 1969, the following proposed works be referred to the Parliamentary Standing Committee on Public Works for investigation and report: Construction of primary and preschools at Bradshaw (Alice Springs) and Nakara (Darwin), N.T.

Mr Chipp presented plans in connection with the proposed works.

Debate ensued.

Question-put and passed.

10 NORTHERN TERRITORY DEVELOPMENT ROADS—APPROVAL OF WORK: Mr Chipp (Acting Minister for Works) moved, pursuant to notice—That, in accordance with the provisions of the *Public Works Committee Act* 1969, it is expedient to carry out the following proposed work which was referred to the Parliamentary Standing Committee on Public Works and on which the committee has duly reported to Parliament: Construction of Northern Territory development roads (1971 reference). Debate ensued.

Question-put and passed.

11 REPATRIATION BILL (No. 2) 1971: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr Barnard (Deputy Leader of the Opposition) who moved, as an amendment—That all words after "That" be omitted with a view to inserting the following words in place thereof: "whilst not opposing the provisions of the Bill the House condemns the Government because—

- (1) it has failed to restore the relative values of repatriation pensions and
- (2) the Bill does not provide for the appointment of a select committee to review the Repatriation Act, its operation and all of its provisions, and to make appropriate recommendations to the Government".
- Debate continued.

Amendment negatived.

- Question—That the Bill be now read a second time—put and passed—Bill read a second time.
- *Message from the Governor-General:* Message No. 142, dated 25 August 1971, from His Excellency the Governor-General was announced recommending an appropriation of revenue for the purposes of the Bill.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Holten (Minister for Repatriation), the Bill was read a third time.

12 ADJOURNMENT: Mr Swartz (Leader of the House) moved—That the House do now adjourn.

Question—put and passed.
