# **VOTES AND PROCEEDINGS**

## No. 128

WEDNESDAY, 13 OCTOBER 1971

- 1 The House met, at half-past two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 PETITIONS: Mr Wentworth (Minister for Social Services) presented a petition from certain citizens of Australia praying that the Government will (a) ban the shooting of kangaroos for commercial purposes, (b) ban the export of all kangaroo products from Australia, (c) prevent the extinction of the red kangaroo, (d) institute a scientific survey of the kangaroo population, (e) establish large national parks of good quality land as major tourist attractions and (f) take control of and be completely responsible for the management of Australia's wildlife.
  - Mr Chipp (Minister for Customs and Excise) presented a petition from certain residents of Victoria praying that the Australian Government will grant a further \$10 million immediate aid to the East Pakistani refugees in India and will take the initiative in urging the instatement of Sheikh Mujibur Rahman as the elected leader of his people and in creating a political climate which will enable the refugees now in India to make a speedy, safe return to their own country.
  - Mr Chipp and Mr Garrick each presented a petition from certain citizens of Australia praying that this House (a) increase monetary aid for the East Pakistani refugees to at least \$5 million immediately, (b) encourage and sponsor teams of volunteers with needed skills and medical supplies and (c) maintain this aid for the period of the crisis. Petitions severally received.
  - Mr Whitlam (Leader of the Opposition) presented a petition from certain citizens of Australia praying that this House take immediate steps to ensure that emergency finance from the Commonwealth will be given to the States for their public education services which provide schooling for 78 per cent of Australia's children.
  - Petition received and read.
  - Similar petitions to that presented by Mr Whitlam were presented by Mr L. K. Johnson, Mr Connor, Mr Reynolds and Mr Grassby, and were severally received.
  - Mr Reid presented a petition from certain citizens of Australia praying that the Government will provide \$10 million for relief purposes in India and East Pakistan, and a further \$50 million over 3 years to help rehabilitate the refugees in East Pakistan.
  - Mr King presented a petition from certain citizens of Australia praying that the Government grant income tax deduction for donations over \$2 made towards the relief of overseas disaster areas and that this be effected with haste to ensure the maximum possible aid to those at present in refugee camps and those in danger of famine in East Pakistan.
  - Mr Connor also presented a petition from certain citizens of the Commonwealth praying that this House raise to \$10 million Australian aid to refugees now in India from East Pakistan and give support to all efforts to guarantee the fully autonomous development of the people of Bangla Desh.

Petitions severally received.

Mr Hamer presented a petition from certain residents of Victoria praying that the Government will immediately grant a further \$10 million in aid to Pakistan refugees and use all diplomatic channels available to urge the creation of a political climate in East Pakistan which will enable the nine million refugees in India to return to their homeland.

- Mr Wallis presented a petition from certain electors of the Division of Grey praying that the Government re-examine the question of financial assistance for the construction of the Lock-Kimba pipe line in South Australia in order that its completion can be expedited and by doing so alleviate the hardships experienced in the area due to a lack of an available and reticulated water supply.
- Mr England presented a petition from certain citizens of the community of Parkes, N.S.W., praying that this House take note of the evil effects of the proposed closing of the divisional telecommunications office at Parkes and that it designate Parkes to be the divisional headquarters for the Parkes, Bathurst and Dubbo telecommunications divisions which are to be amalgamated.

Petitions severally received and read.

- Mr Morrison and Mr Webb each presented a petition from certain citizens of the Commonwealth praying that the sales tax and customs duties on all forms of contraceptive devices be removed, and that all contraceptive devices be placed on the National Health Scheme Pharmaceutical Benefits list.
- Mr Enderby presented a petition from certain residents of the Australian Capital Territory praying that a committee of inquiry, on which are represented the Department of Education and Science, institutions of tertiary education, practising educators, and the Canberra community, be instituted to inquire into the form that an Australian Capital Territory Education Authority should take, the educational principles and philosophy that should underly it, and its mode of operation and administration. Petitions severally received.

6 NATIONAL HEALTH BILL 1971 [No. 2]: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time— Debate resumed by Mr Hayden who moved, as an amendment—That all words after "That" be omitted with a view to inserting the following words in place thereof:

"while not opposing the second reading of the Bill, the House is of opinion that— (1) the Commonwealth nursing home policy is unsatisfactory because of—

- (a) its costliness to patients and their families, and
- (b) an inadequate provision of alternative forms of accommodation and domiciliary services;
- (2) the system of voluntary insurance for medical services is on the point of collapse because of—
  - (a) the failure of subsidised medical benefits for low income earners,
  - (b) widespread non-observance of the most common fee, and
  - (c) the spiralling cost of medical insurance through the wasteful use of funds, and

(3) pharmaceutical benefits should be provided at no cost to the patient". Debate continued.

Suspension of standing orders moved—Motion without notice: Mr Kennedy moved— That so much of the standing orders be suspended as would prevent the honourable Member for Bendigo (Mr Kennedy) moving that this House is of the opinion that a select committee should be set up immediately to investigate and recommend on health care needs of underprivileged groups in Australia.
