WEDNESDAY, 27 OCTOBER 1971

- 1 The House met, at half-past two o'clock p.m., pursuant to adjournment. The Acting Speaker (Mr Lucock) took the Chair, and read Prayers.
- 2 PETITIONS: Mr Calwell presented a petition from certain citizens of the Commonwealth praying that this House raise to \$10 million Australian aid to refugees now in India from East Pakistan and give support to all efforts to guarantee the fully autonomous development of the people of Bangla Desh.

Petition received and read.

- Mr Reid presented a petition from certain citizens of Australia praying that this House (a) increase monetary aid for the East Pakistani refugees to at least \$5 million immediately, (b) encourage and sponsor teams of volunteers with needed skills and medical supplies and (c) maintain this aid for the period of the crisis.
- Mr Armitage and Mr Staley each presented a petition from certain citizens of Australia praying that the Government go beyond the plea of the Prime Minister for magnanimity and compassion in the trial of Sheikh Mujibur Rahman on charges of treason and insist on the liberty of this openly and democratically elected leader.
- Mr Street, Mr Enderby and Mr Wallis each presented a petition from certain citizens of Australia praying that this House should (1) increase monetary aid for the refugees in India to at least \$10 million immediately and make provision for a further and extra grant for the victims of the famine in East Pakistan, (2) grant tax deductibility to donations of \$2 and over to Australian voluntary agencies working with the refugee problem and (3) ensure that the Australian Government does all in its power to help bring about a political settlement which would be acceptable to the people of East Pakistan.
- Mr Brown presented a petition from certain citizens of the Commonwealth praying that the Government (1) give immediate aid of at least \$10 million to help relieve the suffering of Pakistani refugees in India, (2) take the necessary diplomatic steps to seek a political solution and (3) urge the United Nations to make a more effective effort to intervene on behalf of these stricken people.
- Mr Street, Mr Brown and Mr Staley each presented a petition from certain citizens of Australia praying that this House (1) increase monetary aid for the Pakistani refugees to at least \$10 million immediately, (2) encourage and sponsor teams of volunteers with needed skills and medical supplies and (3) maintain this aid for as long as the crisis persists.
- Mr Reynolds presented a petition from certain citizens of Australia praying that the Government grant income tax deduction for donations over \$2 made towards the relief of overseas disaster areas and that this be effected with haste to ensure the maximum possible aid to those at present in refugee camps and those in danger of famine in East Pakistan.
- Mr Enderby also presented a petition from certain residents of the Australian Capital Territory praying that a committee of inquiry, on which are represented the Department of Education and Science, institutions of tertiary education, practising educators, and the Canberra community, be instituted to inquire into the form that an Australian Capital Territory Education Authority should take, the educational principles and philosophy that should underly it, and its mode of operation and administration.

- Mr Bennett and Mr Berinson each presented a petition from certain citizens of the Commonwealth praying that the sales tax and customs duties on all forms of contraceptive devices be removed, and that all contraceptive devices be placed on the National Health Scheme Pharmaceutical Benefits list.
- Mr Hayden, Mr Gun and Mr Sherry each presented a petition from certain citizens of the Commonwealth praying that the Federal Government take immediate steps to act on behalf of all Australian people to preserve Lake Pedder in its natural state.
- Mr Wallis also presented a petition from certain electors of the Division of Grey praying that the Government re-examine the question of financial assistance for the construction of the Lock-Kimba pipe line in South Australia in order that its completion can be expedited and by doing so alleviate the hardships experienced in the area due to a lack of an available and reticulated water supply.

Petitions severally received.

- 3 MINISTERIAL ARRANGEMENTS: Mr Anthony (Minister for Trade and Industry) informed the House that, during the absence abroad of Mr McMahon (Prime Minister), he would act as Prime Minister.

- 14 EAST PAKISTANI REFUGEES-EMERGENCY RELIEF AID-MINISTERIAL STATEMENT, 27 OCTOBER 1971—PAPER NOTED: Mr N. H. Bowen (Minister for Foreign Affairs), by leave, made a ministerial statement informing the House of the Government's decision to make a grant of additional financial aid to East Pakistani refugees, and, by command of His Excellency the Governor-General, presented the following paper:

East Pakistani refugees-Emergency relief aid-Ministerial statement, 27 October 1971.

Mr Swartz (Leader of the House) moved—That the House take note of the paper.

Mr Beazley moved, as an amendment—That the following words be added to the motion: "but the House is of the opinion that the situation in West Bengal and East Pakistan is such that the level of Australian aid should be raised to the equivalent of at least one dollar for each person in Australia".
